In accordance with the constitutionally guaranteed autonomy of the University and pursuant to the Higher Education Act (Official Gazette of the Republic of Slovenia, No. 32/12 – official consolidated version, with amendments, supplementations and corrections) and the Ordinance on the reorganisation of the University of Ljubljana (Official Gazette of the Republic of Slovenia, No. 28/00, with amendments, supplementations and corrections), the Senate of the University of Ljubljana, at its session on 30 May 2023, and the Governing Board of the University of Ljubljana, at its session on 25 May 2023, adopted the following

## Amendments to the Statutes of the University of Ljubljana

## Article 1

The first paragraph of Article 57 of the Statutes of the University of Ljubljana (*Official Gazette of the Republic of Slovenia*, Nos. 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 – corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22 and 156/22) shall be amended to read:

"In accordance with the provisions of these Statutes, in procedures for exercising the rights of students or persons without student status who are fulfilling their academic requirements, the University Student Complaints Committee shall make decisions as an appeal body when a decision has already been made at first instance by the senate of a member institution or its dean or the Rector, unless the Statutes provide otherwise."

## Article 2

A new Article 57a shall be added to the Statutes of the University of Ljubljana (*Official Gazette of the Republic of Slovenia*, Nos. 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 – corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22 and 156/22), to read as follows:

"The University Committee for Applicants' Complaints in Application and Admission Procedures Article 57a

The University Committee for Applicants' Complaints in Application and Admission Procedures shall be appointed by the Senate and presided over by the vice-rector in charge of academic affairs.

The Committee shall decide on complaints from applicants in the procedure for recognising the qualifications required for enrolment in undergraduate or fast-track master's programmes. Complaints must be filed within eight days of receiving the decision.

The Committee shall also decide on complaints from applicants for enrolment in undergraduate or fast-track master's programmes who have not been admitted into the desired programme as part of the application and admission procedures. Complaints must be filed within 15 days of receiving the decision on the results of the selection procedure.

The Committee's decision shall be final."

## Article 3

These amendments shall enter into force on the day after their publication in the Official Gazette of the Republic of Slovenia.
