



In accordance with the constitutionally guaranteed autonomy of the University and pursuant to the Higher Education Act (Official Gazette of the Republic of Slovenia, No. 32/12 – official consolidated version, with amendments, supplementations and corrections) and the Order on the Reorganisation of the University of Ljubljana (Official Gazette of the Republic of Slovenia, No. 28/00, with amendments, supplementations and corrections), the Senate of the University of Ljubljana, at its session of 19 December 2023, and the Governing Board of the University of Ljubljana, at its session of 25 January 2024, adopted the following

### **amendments to the Statutes of the University of Ljubljana**

#### Article 1

Article 35 of the Statutes of the University of Ljubljana (Official Gazette of the Republic of Slovenia, Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 – corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23 and 112/23) shall be amended to read:

#### 'Article 35

The Rector heads and represents the University, and in particular:

1. guarantees and is responsible for the lawfulness of the work of the University and for fulfilling its obligations as laid down by law and other regulations and by the general acts of the University;
2. signs University documents and contracts that the University concludes with other legal entities;
3. convenes and chairs the sessions of the University Senate;
4. coordinates the educational, research and development and artistic and other work of the University member faculties in implementing the national higher education programme;
5. with the approval of the Senate, adopts guidelines and standards for quality assurance in the operation of the University;
6. appoints vice rectors from among candidates approved by the Senate, and assigns them areas of work;
7. proposes to the Governing Board the appointment of the Secretary General;
8. based on elections, appoints deans of the member faculties;
9. appoints deans of member faculties if a member faculty fails to elect a dean;
10. decides, upon the proposal of a member faculty's dean, on the conclusion and termination of the employment contracts of teaching staff and consenting to their work outside the university;
11. defines the classification and structure of job positions at the University, including the positions within the administration on the proposal of the Secretary General of the University;
12. on the approval of the University Senate, adopts the criteria for the evaluation of the work of higher education teachers and higher education and research associates;
13. confers doctoral degrees in the sciences and arts;
14. presents University awards and marks of recognition;
15. reports on the work of the University to the Senate, the Governing Board and the founder;
16. issues decisions on the calling and holding of elections of members of the University Senate, Governing Board and Student Council;
17. appoints working groups to perform tasks that are important for the University;
18. decides on the recognition of educational qualifications obtained abroad for enrolment in the first year of undergraduate and integrated master's study programmes at the University;



19. performs other tasks in accordance with the law, these Statutes and other general acts of the University.

The Rector may authorise vice rectors, deans of member faculties and the University Secretary General for the performance of individual tasks within his/her competence. During a period of extended absence of a dean or the Secretary General, the Rector may transfer the powers delegated to the dean to a vice dean appointed by the dean as a deputy in their absence, and to the Assistant Secretary General appointed for the period of absence by the Secretary General.'

## Article 2

Article 52 of the Statutes of the University of Ljubljana (Official Gazette of the Republic of Slovenia, Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 – corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23 and 112/23) shall be amended to read:

### 'Article 52

The University Senate:

1. adopts the development strategy of the University and proposes to the founder the adoption of appropriate measures for its fulfilment;
2. approves the annual work plan of the University;
3. adopts the Statutes of the University in the same wording as the Governing Board;
4. upon obtaining the prior opinion of the Governing Board regarding the fulfilment of material and financial conditions, it decides on the transformation of the University and other status changes;
5. provides an opinion on proposals under the national higher education programmes and proposals for research and development activities;
6. adopts general acts of the University for the areas of educational, artistic and research and development activities of the University;
7. adopts the guidelines and strategy for research, development and artistic work at the University;
8. adopts the single strategy for common organisational units of the University and other documents;
9. on the proposal of a member faculty senate, approves proposed doctoral dissertations and determines the content for the operation of the Doctoral School;
10. on the proposal of a member faculty senate, adopts study programmes and changes to the compulsory components of programmes;
11. approves the call for enrolment in study programmes;
12. on the proposal of a member faculty, appoints members of programme councils for interdisciplinary study programmes;
13. provides opinions on initiatives to establish higher education institutes;
14. adopts criteria and procedures for elections to titles of higher education teachers, researchers and higher education and research associates;
15. adopts the criteria for the recognition of important works of art in the election of higher education teachers of artistic disciplines;
16. appoints the working bodies of the University Senate and determines their tasks;
17. gives its assent to the criteria for quality assessment and adopts guidelines for the improvement of scientific research, artistic and educational work of the member faculties;
18. adopts the business report and quality report (self-evaluation report) with the same wording as the UL Governing Board;
19. gives the University member faculties, through the Habilitation Commission, its assent before the first election and third and all subsequent elections to a higher title for teaching and research staff, except for full professors and senior research fellows;
20. elects candidates to the titles of full professor and senior research fellow;
21. upon appeal at the second instance, elects candidates to titles, except the titles of full professor and senior research fellow;



22. decides on the appeal of a candidate against a decision of the senate of a member faculty on election to a title;
23. decides on the revocation of the scientific title of doctor of science and the arts title of doctor of arts;
24. decides on the granting of an honorary doctorate, the title of 'Professor Emeritus' and the title of 'Honorary Senator of the University of Ljubljana';
25. adopts the outline academic calendar;
26. approves candidates for vice rectors;
27. deliberates and decides on the opinions of the University Student Council in the fields under its competence;
28. conducts other duties and decides on other matters that are not assigned for decisions by another body of the University.

The Senate may authorise a working body of the University Senate to carry out certain tasks under its competences.'

### Article 3

Article 64 of the Statutes of the University of Ljubljana (Official Gazette of the Republic of Slovenia, Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 – corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23 and 112/23) shall be amended to read:

#### 'Article 64

The Governing Board (previously referred to as Administrative Board):

1. adopts the Statutes of the University in the same wording as the University Senate;
2. adopts general acts that govern the management of the University, its financial operations and employment relations;
3. adopts the criteria for the disbursement of funds from the budget of the Republic of Slovenia for academic activities;
4. adopts the criteria for the delimitation of assets obtained from public and other funds, and the criteria for apportioning expenditure for the performance of the public service and for other activities;
5. sets the percentage of the member faculties' compensation for common tasks and is briefed on the use of these assets in the annual report;
6. upon the preliminary assent of the University Senate to the annual action plan, adopts the annual work programme and monitors its implementation;
7. adopts the annual report;
8. decides on matters of an economic and financial nature and ensures the smooth financial operation of the University;
9. sets the prices for the sale of goods and services on the market and adopts a bylaw regulating the sale of goods and sales on the market;
10. provides a preliminary opinion on the financial consequences of the introduction of new study programmes and the call for enrolment;
11. provides a preliminary opinion regarding the fulfilment of the material and financial conditions upon the foundation of a new member faculty, the termination of a member faculty and upon other status changes;
12. submits its proposals and opinions to the Founder and the Rector regarding specific issues;
13. adopts the basic framework for job classification;
14. adopts the rules on the internal organisation of the University;



15. on the proposal of the Rector and based on a public call, appoints the Secretary General of the University;
16. on the proposal of member faculties, adopts decisions on tuition fees and other academic contributions;
17. adopts decisions on managing the University's assets;
18. adopts other decisions relating to the management of the University.'

##### 'Article 74

The sessions of the senate are convened and chaired by the Dean.

The member faculty senate deliberates and decides on professional matters in the areas of research and development, and the artistic and educational work of the member faculty.

The member faculty senate:

1. adopts the regulations of the member faculty, which must be harmonised with these Statutes;
2. proposes the study programmes intended to obtain academic qualifications and advancement to the University for adoption;
3. gives its assent to the criteria for the evaluation of work of the member faculty's higher education teachers and higher education and research associates;
4. adopts non-formal education programmes;
5. in the procedure of election to the title of higher education teacher, researcher and higher education and research associate, appoints rapporteurs on the qualifications of the candidate;
6. elects candidates to the title of higher education teacher, researcher and higher education and research associate, except for the titles of full professor and senior research fellow;
7. proposes to the University Senate candidates for election to the titles of full professor and senior research fellow;
8. adopts the annual work programme and annual report of the member faculty;
9. sets the conditions for the supervisor, and the procedures for the acceptance, writing, defence and evaluation of the final thesis for first and second cycle study programmes;
10. decides on the revocation of all academic and scientific titles, except on the revocation of the scientific title of doctor of science and arts title of doctor of arts;
11. appoints the commission for monitoring a doctoral student;
12. decides on extension of the deadline for submission of a doctoral dissertation;
13. proposes to the University Senate for approval proposed doctoral dissertation topics;
14. appoints working bodies of the member faculty senate;
15. formulates proposals for University commendations;
16. deliberates on the opinions of the member faculty's student council within its competence;
17. ensures monitoring of the quality of educational, scientific research and artistic work and adopts the self-evaluation report;
18. performs other tasks and decides on other matters that are not assigned for decisions by another body of the member faculty.

The member faculty defines the method of work of its senate through regulations.'

‘Article 87

A student who has completed all obligations of the study programme that was accredited upon his/her enrolment obtains an academic, scientific or arts title in accordance with the law and study programme.’

Article 6

‘Article 132

Studies are completed with a final assignment, except when a first-cycle study or integrated master’s study programme stipulates otherwise. In accordance with the study programme, the final assignment may have the form of a written paper or other produced work, a performance, presentation, etc., and must meet the quantity and quality requirements for the completion of a final assignment.

The student is bound to complete the final assignment in accordance with the study programme and the member faculty’s rules, and to submit it in the prescribed form.

The final assignment must be the result of the independent work of the student. Students must demonstrate in the assignment that they master the field of study in terms of its fundamental, applied or research and development dimensions with regard to the level of the study programme and the qualification level in which the learning outcomes of the study programme are ranked. Furthermore the final assignment in a third-cycle study programme must be an independent and original scientific contribution to the scientific field or an original artistic contribution in the field of the arts covered by the final assignment topic.

A final assignment, with the exception of a final assignment in a third-cycle study programme, may also be the result of the work of multiple students, wherein there must be a clear indication of the contribution of the individual student, who must fulfil his/her own individual obligations in the final assignment in terms of quantity and quality.’

‘Article 135

The procedures for obtaining a doctorate in science and a doctorate in the arts are defined in detail in University regulations.’

Article 8

'Article 136

The graduate's academic, scientific or arts title is revoked if it is found, after it has been awarded, that:

- the graduate's proof of fulfilling enrolment conditions was fraudulent;
- the graduate did not complete all of the requirements under the study programme;
- the graduate's proof of completing the course requirements was fraudulent;
- in their final assignment (degree thesis, master's thesis, doctoral dissertation) prescribed in the study programme, the graduate made copyrighted work of others look like their own in a significant part of the assignment by not following the established citation rules;
- a significant part of the final assignment (degree thesis, master's thesis, doctoral dissertation) prescribed in the study programme is not the result of the graduate's own work, creativity and achievements.'

'Article 137

The University Senate decides on the revocation of the scientific title of doctor of science and the arts title of doctor of arts.

The revocation of all other academic and scientific titles is decided upon by the senates of the University member faculties that conducted the study programme based on which the graduate obtained his/her title.

If the member faculty referred to in the previous paragraph no longer exists, the revocation shall be decided by the senate of the member faculty conducting the same or a similar programme in terms of content. If an identical or similar programme no longer exists, the revocation of the academic or scientific title shall be decided upon by the Senate of the University.'

Article 10

'Article 138

The proposal to begin the process of revoking a scientific, arts or academic title must be made by the Rector or Dean, if circumstances exist indicating that the conditions for the revocation of the scientific, arts or academic title are probably met.

The competent senate decides on the proposal of the Rector or Dean.

If the senate is of the opinion that the proposal is justified, it adopts a decision whereby it initiates the title revocation procedure, and appoints a person authorised to conduct the procedure until the decision is issued (hereinafter: authorised person).

In cases of initiating the procedure referred to in the fourth or fifth indents of Article **Napaka! Vira sklicevanja ni bilo mogoče najti.** of these Statutes, the senate appoints a commission of three higher education teachers who draft separate reports on the reasons for the revocation of title.



Any person who took part in the process of obtaining the academic, scientific or arts title as mentor, co-mentor or member of the commission for the evaluation of the graduate's final assignment as prescribed in the study programme, cannot be a member of the revocation commission or the authorised person.'

##### 'Article 139

The authorised person informs the graduate who is subject to the process (hereinafter: the graduate) that the process to revoke the scientific, arts or academic title has been initiated. The graduate may participate in the process themselves or through a person with power of attorney.

The graduate shall have the right to inspect all of the documents pertaining to the matter with the authorised person, to be informed of the status of the matter, to put forward evidence in his/her favour and to exercise all other rights he/she has as a party to the proceedings, with the application mutatis mutandis of the act governing general administrative procedures, unless the procedure is regulated otherwise by these Statutes.'

##### 'Article 141

The revocation of an academic, scientific or arts title is decided upon in a session of the competent senate referred to in Article **Napaka! Vira sklicevanja ni bilo mogoče najti.** of these Statutes.

If the senate finds that any of the reasons for the revocation of the academic, scientific or arts title exist, it issues a decision whereby the title in question is revoked, otherwise it halts the procedure by official decision.

The academic, scientific or arts title is revoked with effect on the date of the graduate being handed the decision.'

#### Article 13

##### 'Article 142

The right to use the academic, scientific or arts title ceases upon the handing of the decision on revocation of the title to the graduate.

After the senate's decision to revoke the title is handed to the graduate, the University revokes the validity of the issued certificate in the Official Gazette of the Republic of Slovenia.  
The University keeps a record of the titles it has awarded and revoked.'

'Fields of study at individual faculties and arts academies, classified in accordance with the decree on the introduction and use of the KLASIUS-P-16 education and training classification system, are specified for each individual member faculty.

Fields of study by member faculties are defined by the classification of study programmes carried out independently by member faculties in at least one of three cycles, into broad KLASIUS-P-16 fields. Individual study programmes carried out jointly by two or more member faculties are interdisciplinary study programmes comprising content from various KLASIUS-P-16 academic fields (e.g. options, fields or sets). Each member faculty participates in carrying out interdisciplinary programmes with content from the fields set out for the member faculty in this Annex.

- **Biotechnical Faculty:** (01) Education science and teacher training, (05) Natural science, mathematics and statistics, (07) Technology, production technology and construction, (08) Agriculture, forestry, fishery and veterinary science (*participates in carrying out the interdisciplinary Master's study programme in Applied Statistics and interdisciplinary doctoral study programmes in Biosciences, Biomedicine, Statistics, Environmental Protection and Art*);

- **School of Economics and Business:** (03) Social sciences, journalism and information science, (04) Business and administrative sciences, law (*participates in carrying out the interdisciplinary Master's study programmes in Sports Management and Applied Statistics, as well as interdisciplinary doctoral study programmes in Statistics and Environmental Protection*);

- **Faculty of Architecture:** (07) Technology, production technology and construction (*participates in carrying out the interdisciplinary doctoral study programme in Art*);

- **Faculty of Arts:** (01) Education science and teacher training, (02) Arts and humanities, (03) Social sciences, journalism and information science, (05) Natural science, mathematics and statistics ***(participates in carrying out the interdisciplinary Master's study programme in Cognitive Science and interdisciplinary doctoral study programmes in Humanities and Social Sciences, Statistics and Environmental Protection);***
- **Faculty of Medicine:** (09) Health and social security ***(participates in carrying out the interdisciplinary Master's study programmes in Cognitive Science and Applied Statistics, and interdisciplinary doctoral study programmes in Biomedicine, Statistics and Environmental Protection);***
- **Faculty of Natural Sciences and Engineering:** (02) Arts and humanities, (05) Natural science, mathematics and statistics, (07) Technology, production technology and construction ***(participates in carrying out the interdisciplinary doctoral study programmes in Built Environment, Environmental Protection and Art);***



- **Faculty of Education:** (01) Education science and teacher training (*participates in carrying out the interdisciplinary Master's study programmes in Cognitive Science and Computer and Information Science Education*);
- **Faculty of Law:** (04) Business and administration, law (*participates in carrying out the interdisciplinary doctoral study programme in Environmental Protection*);
- **Faculty of Theology:** (01) Education science and teacher training, (02) Arts and humanities, (03) Social sciences, journalism and information science (*participates in carrying out the interdisciplinary doctoral study programme in Humanities and Social Sciences*);
- **Veterinary Faculty:** (08) Agriculture, forestry, fishery and veterinary science (*participates in carrying out the interdisciplinary doctoral study programmes in Biomedicine and Environmental Protection*);
- **Faculty of Health Sciences:** (09) Health and social security (*participates in carrying out the interdisciplinary doctoral study programme in Biosciences*);
- **Academy of Music:** (01) Education science and teacher training, (02) Arts and humanities (*participates in carrying out the interdisciplinary doctoral study programmes in Humanities and Social Sciences and Art*);
- **Academy of Theatre, Radio, Film and Television:** (02) Arts and humanities (*participates in carrying out the interdisciplinary doctoral study programmes in Humanities and Social Sciences and Art*);
- **Academy of Fine Arts and Design:** (02) Arts and humanities (*participates in carrying out the interdisciplinary first-cycle academic study programme in Design Engineering and interdisciplinary doctoral study programmes in Humanities and Social Sciences and Art*).

The interdisciplinarity of content in individual study programmes shall be enabled and ensured also in all study programmes where it is necessary to achieve the objectives of individual study programmes (the expected knowledge, competences and skills of graduates) and which are not specifically defined as interdisciplinary. The specific content of study programmes may also fall within other broad, narrow or detailed KLASIUS-P-16 fields in which the programmes or member faculties are not classified under this Annex (e. g. the programmes in Speech therapy and deaf/hearing impaired education; Mathematics and statistics; Teacher training and education science; the doctoral study programme in Biosciences and others).'

These amendments shall enter into force on the day after their publication in the Official Gazette of the Republic of Slovenia.
