



In accordance with the constitutionally guaranteed autonomy of the University and pursuant to the Higher Education Act (Official Gazette of the Republic of Slovenia, No. 32/12 - official consolidated version, with amendments, supplementations and corrections) and the Order on the reorganisation of the University of Ljubljana (Official Gazette of the Republic of Slovenia, No. 28/00, with amendments, supplementations and corrections), the Senate of the University of Ljubljana, at its session of 26 March 2024, and the Governing Board of the University of Ljubljana, at its session of 28 March 2024, adopted the following

amendment to the Statutes of the University of Ljubljana

Article 1

A new Article 152a shall be added to the Statutes of the University of Ljubljana (Official Gazette of the Republic of Slovenia, Nos. 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 - corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 112/23 and 12/24), to read as follows: "Notwithstanding the provisions of the preceding Article, assessments of the qualifications of candidates in the procedure of first election to the title of Assistant or Assistant-Researcher may be formulated for all candidates by a permanent committee at the member faculty, within one month at the latest of the candidate lodging an application. The committee shall make a joint assessment of the candidate's qualifications.

The committee referred to in the preceding paragraph shall be appointed by the senate of the member faculty for the duration of its term, with members appointed from among the member faculty's employed higher education teachers and/or research associates. The committee shall comprise at least three members. For the purpose referred to in the preceding paragraph the senate of the member faculty may also appoint multiple permanent committees.

If the senate of the member faculty appoints a committee referred to in the first paragraph, all procedures of the first election to the title Assistant or Assistant-Researcher at the member faculty shall be conducted in accordance with the provisions of this Article.

The provisions of the preceding Article shall apply mutatis mutandis to accessing the committee's assessment of a candidate's qualifications, the opinion of the student council, notification of the candidate regarding the committee's assessment of the candidate's qualifications, the possibility of the candidate taking a position regarding the assessment and to the elapsing of deadlines.

For each new election to the title Assistant or Assistant-Researcher, the procedure of election to the title shall be conducted in accordance with the preceding Article."

Article 2

This amendment shall enter into force on the day after its publication in the Official Gazette of the Republic of Slovenia.
