

In accordance with the constitutionally guaranteed autonomy of the University and pursuant to the Higher Education Act (Official Gazette of the Republic of Slovenia, No. 32/12 – official consolidated version, with amendments, supplementations and corrections) and the Order on the Reorganisation of the University of Ljubljana (Official Gazette of the Republic of Slovenia, No. 28/00, with amendments, supplementations and corrections), the Senate of the University of Ljubljana, at its session of 23 April 2024, and the Governing Board of the University of Ljubljana, at its session of 25 April 2024, adopted the following

## amendments to the Statutes of the University of Ljubljana

#### Article 1

Article 34 of the Statutes of the University of Ljubljana (Official Gazette of the Republic of Slovenia, Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 – corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23, 112/23 and 12/24) shall be amended to read:

"The procedures for running as candidate, election and dissolving of University bodies shall, where they are not regulated by these Statutes, be regulated by rules adopted by the University Senate. For provisions defining elections to the University Student Council, the University Senate must obtain the prior approval of the University Student Council."

### Article 2

Article 39 of the Statutes of the University of Ljubljana (Official Gazette of the Republic of Slovenia, Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 – corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23, 112/23 and 12/24) shall be amended to read:

"Eight months prior to the expiry of the Rector's term of office the University Senate shall adopt a decision initiating the procedure for election of a new Rector and shall appoint an Election Commission.

Within 30 days of the initiation of the procedure, the senates of member faculties shall propose candidates.

The Election Commission shall publish a list of candidates after the expiry of the deadline for registration of candidates."

## Article 3

Article 43 of the Statutes of the University of Ljubljana (Official Gazette of the Republic of Slovenia, Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 – corrigendum, 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23, 112/23 and 12/24) shall be amended to read:

"The University shall have a maximum of five Vice-Rectors, who are in charge of preparing strategic guidelines and developing the University's activities, whereby they must ensure that various University sectors are represented.

The Vice-Rectors shall be appointed by the Rector. The newly elected Rector must publicly present the Vice-Rectors no later than at the session of the UL Senate at which the Election Commission reports on the outcome of the election of the Rector. In selecting Vice-Rectors the Rector must adhere to the diversity and equality of representation of sectors and fields being cultivated by the UL member faculties, and must strive to achieve balanced gender representation. Based on the Rector's proposal, the UL Senate shall confirm the candidates for Vice-Rector.



A Vice-Rector shall be a full professor employed full-time at the University. A Vice-Rector may not be employed at the member faculty where the Rector is based.

The term of a Vice-Rector is tied to the term of the Rector. The Rector may dismiss a Vice-Rector prior to the expiry of the latter's term."

# Article 4

These amendments shall enter into force on the day after their publication in the Official Gazette of the Republic of Slovenia.
