In accordance with the constitutionally guaranteed autonomy of the University and pursuant to the Higher Education Act (Uradni list RS [Official Gazette of the RS], No 32/12 [official consolidated version], with amendments, additions and corrections) and the Ordinance on the Reorganisation of the University of Ljubljana (Uradni list RS [Official Gazette of the RS], No 28/00, with amendments, additions and corrections), the Senate of the University of Ljubljana, at its session of 18 June 2024, and the Governing Board of the University of Ljubljana, at its session of 11 July 2024, adopted the following

# Amendments to the Statutes of the University of Ljubljana

#### Article 1

The title of Chapter 6.13 of the Statutes of the University of Ljubljana (Uradni list RS [Official Gazette of the RS], Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 [corrigendum], 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23, 112/23, 12/24, 30/24 and 39/24) shall be amended to read:

### '6.13 CONTINUING STUDIES AFTER INTERRUPTION AND DE-ENROLMENT'.

#### Article 2

Article 128 of the Statutes of the University of Ljubljana (Uradni list RS [Official Gazette of the RS], Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 [corrigendum], 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23, 112/23, 12/24, 30/24 and 39/24) shall be amended to read:

### 'Article 128

A student shall be deemed to have interrupted their studies if they do not enrol in a year or additional year and do not at the same time de-enrol from the study programme or course, thereby losing the status of a student on that study programme (hereinafter: candidate).

A student shall be deemed to have de-enrolled if they have withdrawn from a study programme or course, thereby losing the status of a student on that study programme (hereinafter: candidate).

A candidate who has lost student status as a result of interruption may, upon payment of a fee, continue to study for two years after losing their status, unless the programme's accreditation has expired. After two years, they must file an application with the member faculty if they wish to continue or complete their studies. The candidate shall pay to continue or complete their studies on the basis of an approved application.

A candidate who has lost student status as a result of de-enrolment and who wishes to continue or complete the study programme or course in which they were enrolled must file an application to continue or complete their studies with the member faculty regardless of when they lost student status. The candidate shall pay a tuition fee to continue or complete their studies on the basis of an approved application.

The member faculty shall decide on a student's eligibility to continue or complete their studies on the basis of proof of their completion of the study requirements prior to the interruption.

If their application is successful, a determination is made of the year in which the candidate is to continue their studies or the requirements they are required to meet in order to complete their studies. A determination shall also be made of the conditions and requirements that the candidate is required to meet again or meet additionally if, in the interim, there have been changes to the accredited study programme in which they are enrolled or are completing. The member faculty's academic affairs committee or other body specified by member faculty's rules shall decide on this.

Without prejudice to the third paragraph of this article, a candidate who, prior to losing student status, met all the study requirements except the final paper and whose final paper topic was approved no later than six months after they lost student status, may complete their studies without payment, but no later than in two years from losing student status.'

### Article 3

These amendments shall enter into force on the day after they are published in the Uradni list Republike Slovenije (Official Gazette of the Republic of Slovenia).
