



In accordance with the constitutionally guaranteed autonomy of the University and with reference to the Higher Education Act (*Uradni list Republike Slovenije* [Official Gazette of the Republic of Slovenia; UL RS], No 56/25) and the Ordinance on the Reorganisation of the University of Ljubljana (UL RS, No 28/00, with amendments and corrections), the Senate of the University of Ljubljana, at its session of 21 October 2025, and the Governing Board of the University of Ljubljana, at its session of 23 October 2025, adopted the following

Amendment to the Statutes of the University of Ljubljana

Article 1

Article 10 of the Statutes of the University of Ljubljana (UL RS, Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 [corrigendum], 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23, 112/23, 12/24, 30/24, 39/24, 60/24 and 22/25) shall be amended to read:

“Article 10

A member institution of the university is a public institution established by the university. A member institution of the university enters into legal transactions in its own name and on its own behalf. A member institution of the university shall conclude a contract with the university on the performance and financing of the public service.”

Transitional and final provision

Article 2

A member institution of the university shall conclude its first contract on the performance and financing of the public service with the university in 2027, within three months at the latest of the conclusion of the contract on the financing of the public service between the university and the ministry.

Until the conclusion of the contract, Article 10 of the Statutes of the University of Ljubljana (UL RS, Nos 4/17, 56/17, 56/17, 14/18, 39/18, 57/18, 66/18, 10/19, 22/19, 36/19, 47/19, 82/20, 104/20, 168/20, 54/21, 97/21, 159/21, 162/21, 163/21 [corrigendum], 202/21, 39/22, 49/22, 60/22, 135/22, 156/22, 64/23, 77/23, 77/23, 112/23, 12/24, 30/24, 39/24, 60/24 and 22/25) shall apply to the performance and financing of the public service referred to in the first paragraph of this Article, including research activities obtained and financed through European and other international collaborations and projects financed from public funds.



Article 3

The amendment to Article 10 of the Statutes of the University of Ljubljana shall enter into force on the day after its publication in *Uradni list Republike Slovenije* [Official Gazette of the Republic of Slovenia].
