Mladi raziskovalec oz. mlada raziskovalka se bo zaposlil/-a na Fakulteti za družbene vede, Univerze v Ljubljani, kjer bo raziskoval/-a ekonomsko in gospodarsko diplomacijo med Evropsko unijo (EU) in Ljudsko republiko Kitajsko, s posebnim poudarkom na vplivu kitajskih investicij na regijo Srednje in Vzhodne Evrope (CEE) ter Slovenijo. Hkrati se bo vpisal/-a na interdisciplinarni doktorski študij na Fakulteti za družbene vede, kjer bo v okviru raziskovalnega dela preučeval/-a spremembe v diplomatskih strategijah Kitajske in EU ter njihove posledice za diplomatske odnose med regijama, trgovinske in investicijske tokove ter izvajanje javne, ekonomske, razvojne in kulturne diplomacije Ljudske republike Kitajske v odnosu do EU in obratno.

Diplomatske študije na Fakulteti za družbene vede imajo bogato tradicijo raziskovanja diplomacije, pri čemer se področje ekonomske in gospodarske diplomacije vse bolj uveljavlja kot ključen dejavnik mednarodne politične in ekonomske dinamike. Zato bo usposabljanje mlade/-ga raziskovalke/-ca osredotočeno na metodološko utemeljeno raziskovanje sodobnih diplomatskih procesov in empirično analizo v diplomatskih študijah, področje, ki je bilo do sedaj v veliki meri znanstveno in strokovno prezrto.

Usposabljanje in delo bo zajemalo razvoj naprednih metodoloških znanj, tako kvalitativnih kot kvantitativnih metod, v vsebinskem smislu pa tudi poglabljanje ekspertize na področju ekonomske in gospodarske diplomacije ter razvojne diplomacije Kitajske in EU.

Prvi, študijski del raziskovalnega dela bo usmerjen v pridobivanje in poglabljanje ključnih metodoloških orodij v diplomatskih študijah, pri čemer bo poudarek na analizi mednarodnih ekonomskega in gospodarske diplomacije ter razvojnih politik. Raziskovalec/-ka bo razvil/-a epistemološke in metodološke temelje za preučevanje ekonomske in gospodarske diplomacije kot interdisciplinarnega področja, ki združuje diplomacijo, mednarodne odnose in trgovinsko politiko (v najširšem pomenu).

Osrednji del programa usposabljanja se bo začel z izbiro raziskovalne teme in natančnejšim oblikovanjem predloga doktorske raziskave, ki bo empirično utemeljena in osredotočena na vpliv diplomatskih in ekonomskih politik Kitajske na države CEE in Slovenijo. Sledila bo celovita izvedba raziskave in izdelava doktorske disertacije, ki bo temeljila na kombinaciji analize diplomatskih in diplomatsko-ekonomske prioritete in strategij ter študij primerov.

Usposabljanje bo skozi celotno trajanje vključevalo tudi izvajanje raziskovalnega dela v okviru raziskovalne skupine, sodelovanje pri mednarodnih in nacionalnih raziskovalnih projektih ter objavljanje znanstvenih prispevkov v uglednih revijah s področja diplomacije in mednarodnih ekonomskega odnosov.

The young researcher will work at the Faculty of Social Sciences, University of Ljubljana, where he/she will research economic and commercial diplomacy between the European Union (EU) and the People's Republic of China, with a special focus on the impact of Chinese investment on the Central and Eastern Europe (CEE) region and Slovenia. At the same time, he will be enrolled in an interdisciplinary PhD programme at the Faculty of Social Sciences, where his research will examine changes in the diplomatic strategies of China and the EU and their implications for diplomatic relations between the two regions, trade and investment flows, and the conduct of the People's Republic of China's (PRC) public, economic, development and cultural diplomacy vis-à-vis the EU and vice versa.

Diplomatic studies at the Faculty of Social Sciences have a rich tradition of diplomatic research, with the field of economic and commercial diplomacy increasingly emerging as a key factor in international political and economic dynamics. Therefore, the training of the young researcher will focus on methodologically grounded research on contemporary diplomatic processes and empirical analysis in diplomatic studies, an area that has been largely ignored by scholarship and practitioners.

The training and work will include the development of advanced methodological skills in both qualitative and quantitative methods, as well as deepening substantive expertise in the field of economic and commercial diplomacy and development diplomacy of China and the EU.

The first, academic part of the research will focus on the acquisition and deepening of key methodological tools in diplomatic studies, with an emphasis on the analysis of international economic relations and development policies. The researcher will develop the epistemological and methodological foundations for the study of economic and commercial diplomacy as an interdisciplinary field that combines diplomacy, international relations and trade policy (in the broadest sense).

The main part of the training programme will start with the selection of a research topic and the elaboration of a PhD research proposal, empirically grounded and focused on the impact of China's diplomatic and economic policies on CEE countries and Slovenia. This will be followed by a comprehensive research implementation and the production of a PhD thesis based on a combination of analysis of diplomatic and diplomatic-economic priorities and strategies and case studies.

Throughout the training, research will also focus on conducting research within a research group, participating in international and national research projects, and publishing scientific papers in reputable journals in the field of diplomacy and international economic relations.

Prerequisites:

- Previous degree in a social science or a humanities discipline (International Relations, European studies, Diplomacy, Economics, Political Science).
- Active knowledge of Slovenian and English (written and spoken).

Slov.: Mlada raziskovalka oz. mladi raziskovalec se bo vpisal/a v interdisciplinaren doktorski študij Humanistika in družboslovje na Fakulteti za družbene vede, Univerze v Ljubljani (FDV, UL) in zaposlit/a v Centru za metodologijo in informatik na FDV, UL. Kandidatka oz. kandidat bo delo opravljil/a v okviru področja družboslovne informatike, pri čemer bo razvijal/a interdisciplinarna znanja v povezavi s področji družboslovne metodologije, informatike, komuniciranja zdravja in zdravstva.

Vsebinsko se bo raziskovalno delo mlade raziskovalke oz. mladega raziskovalca nanašalo na temo družbenih vidikov uporabe generativne umetne inteligence na področju zdravja in zdravstva. Orodja generativne umetne inteligence, predvsem konverzacijska umetna inteligencia, postaja vse pogosteji vir z zdravjem povezanih informacij, tako za posameznike, ki jih zanima tema zdravja, kot za paciente z akutnimi ali kroničnimi zdravstvenimi težavami ter zdravstvene delavce. Ključen izziv pri uporabi konverzacijske umetne inteligence kot vira z zdravjem povezanih informacij je vprašanje zaznane kredibilnosti takšnih informacij in njihove uporabe pri odločanju o nadaljnjih z zdravjem povezanih vedenjih. Cilj raziskovanja je proučiti učinke uporabe konverzacijske umetne inteligence na zaznano kredibilnost pridobljenih informacij ter na proces odločanja v povezavi z zdravjem. Program dela bo natančneje vključeval konceptualizacijo in proučevanje večdimenzionalnosti kredibilnosti (z zdravjem povezanih) informacij generiranih s strani konverzacijske umetne inteligence, dejavnikov ocenjevanja kredibilnosti informacij generiranih s strani konverzacijske umetne inteligence (npr. zdravstvena pismenosti na področju umetne inteligence, učinek plastenja virov oz. source layering effect, funkcionalnosti orodij, konverzacijski stil in način predstavitev informacij) in merjenje zaznane kredibilnosti. Ker orodja konverzacijske umetne inteligence uporabnikom ne ponujajo le različna informacijska izhodišča za odločanje, temveč tudi predloge za nadaljnje ukrepanje in delovanje, bo posebna pozornost namenjena proučevanju procesa odločanja v zdravstvenem kontekstu, ki ima lahko pomembne posledice na zdravstvene izide. Natančneješo temo doktorata, raziskovalni in metodološki pristop bo mlada raziskovalka oz. mladi raziskovalec znotraj raziskovalnega področja oblikoval/a in opredelil/a skupaj z mentorico, pri tem pa se bo raziskovanje osredotočalo na izbrano zdravstveno temo.

Od mlade raziskovalke oz. mladega raziskovalca se bo v okviru usposabljanja pričakovalo: redno objavljanje izsledkov raziskovalnega dela na nacionalnih in mednarodnih znanstvenih konferencah, redno objavljanje raziskovalnih izsledkov v znanstvenih publikacijah in revijah, aktivno vključitev v skupnost raziskovalcev na področju proučevanja učinkov umetne inteligence na področju zdravja in zdravstva, uspešno in pravočasno opravljanje študijskih obveznosti na doktorskem študiju.

Eng.: A junior researcher will enrol in the interdisciplinary doctoral study program Humanities and Social Sciences at the Faculty of Social Sciences, University of Ljubljana (FDV, UL) and will be employed at the Centre for Methodology and Informatics at FDV, UL. The candidate will work in the field of social informatics, developing interdisciplinary knowledge related to social science methodology, informatics, and health communication.

The research work of the junior researcher will focus on the social aspects of using generative artificial intelligence in the field of health and healthcare. Generative artificial intelligence tools, particularly conversational AI, are becoming an increasingly used source of health-related information by both individuals interested in health topics and patients with acute or chronic health conditions, as well as healthcare professionals. A key challenge in using conversational AI as a source of health-related information is the issue of perceived credibility of such information and its use in health decision-making process. The aim of the research is to examine the effects of using conversational AI on the perceived credibility of obtained information and on the health decision-making process. The work plan will include the conceptualization and examination of the multidimensionality of credibility of (health-related) information generated by conversational AI, factors influencing the assessment of the credibility of such information (e.g., AI health literacy, the source layering effect, functionalities/affordances of the tools, conversational style, conversational presentation mode), and the measurement of perceived credibility. Since conversational AI tools not only provide users with different informational starting points for decision-making but also offer suggestions for further social practices and behaviour, special attention will be given to studying the decision-making process in a healthcare context, which can have significant consequences for health outcomes. The precise topic of the doctoral research, as well as the methodological approach, will be developed and defined by the junior researcher together with the mentor, focusing on a selected health-related topic.

As part of the training, the junior researcher will be expected to regularly publish research findings at national and international scientific conferences, regularly publish research results in scientific publications and journals, actively engage in the research community studying the effects of artificial intelligence in health and healthcare, and successfully and timely complete study obligations in the doctoral program.

Requirements:

Preference will be given to candidates who, in addition to meeting the general requirements, also possess the following knowledge and qualifications:

Mladi_a raziskovalec_ka se bo usposabljal_a v okviru programa »Analiza dela, izobraževanja in zaposlovanja« ter tekočih raziskovalnih projektov. Raziskovanje bo usmerjeno v analizo različnih vidikov na preseku družbene odgovornosti podjetij in dezinformacij. Pri tem bo poudarek na iskanju novejših pristopov proučevanja in razumevanja problematike (npr. pristopu oz. teoriji organiziranja [Czarniawska]), ki vključujejo omrežja različnih akterjev (npr. medijev, regulatornih organov, preverjevalcev trditev, zaposlenih, potrošnikov ...). Specifika raziskovalnega usposabljanja mladega_e raziskovalca_ke bo v tem, da bo potekalo na presečiščih komunikologije, organizacijskih študij in poslovnega okolja podjetij (tj. "business and society") in temeljilo na prepletu raznolikih konceptualnih pristopov, epistemoloških pogledov in raziskovalnih registrov, katerih skupni imenovalec bo pridobivanje in razvijanje znanj za razumevanje in analizo sodobnih izzivov, s katerimi se srečujejo organizacije v digitalni dobi.

Na študijskem področju se bo mladi_a raziskovalec_ka izobraževal_a v okviru doktorskega študija Humanistika in družboslovje na Fakulteti za družbene vede, tema doktorata pa bo izbrana in konkretizirana v okviru zgoraj opisanih usmeritev raziskovanja.

V okviru raziskovalnega dela in v času priprave doktorske disertacije bo usposabljanje potekalo tudi z udeležbo na nacionalnih in mednarodnih strokovnih dogodkih in konferencah, izmenjavah v tujini, ipd.

Prednost bodo zato imeli kandidati_ke, ki izpolnjujejo naslednje pogoje:

The young researcher will receive training within the framework of the program "Analysis of Work, Education, and Employment" and ongoing research projects. The research will focus on analyzing various aspects at the intersection of corporate social responsibility and disinformation. Emphasis will be placed on exploring new approaches to studying and understanding this issue (e.g., the theory of organizing [Czarniawska]), which include networks of different actors (e.g., media, regulatory bodies, fact-checkers, employees, consumers, etc.).

The specificity of the research training for the young researcher will lie in its interdisciplinary nature, occurring at the crossroads of communication studies, organizational studies, and business and society field. The training will be based on an integration of diverse conceptual approaches, epistemological perspectives, and research frameworks, with the common goal of developing knowledge and analytical skills to understand the contemporary challenges organizations face in the digital age.

In the academic field, the young researcher will be enrolled in the doctoral program in Humanities and Social Sciences at the Faculty of Social Sciences. The doctoral dissertation topic will be selected and concretized within the above-described research orientations.

During the research work and the preparation of the dissertation, training will also include participation in national and international professional events and conferences, exchange programs abroad, and similar activities.

Candidate Requirements

Mladi raziskovalec bo zaposlen Centru za raziskovanje javnega mnenja in množičnih komunikacij na Fakulteti za družbene vede in se vpisal na interdisciplinarni doktorski študij družboslovne metodologije na Fakulteti za družbene vede. Njegovo delo bo umeščeno v metodološko polje s primarno vsebinsko usmeritvijo v mednarodno anketno raziskovanje ter primerjavo sodobnih načinov zbiranja anketnih podatkov ter procesov anketnega raziskovanja.

V prvem obdobju bo študent poglobil metodološko znanje s področja anketne metodologije. Osrednji del programa usposabljanja se bo začel s samostojno izbiro raziskovalne teme in natančnejšim oblikovanjem samostojne raziskave z uporabo sekundarnih in primarnih podatkov iz mednarodnih raziskav, ki potekajo v CMMJK. Usposabljanje bo skozi celotno trajanje vključevalo tudi izvajanje raziskovalnega dela v okviru programske skupine in njenega mednarodnega sodelovanja.

Pogoj je predhodna družboslovna ali statistična izobrazba, ki je vključevala tako kvalitativne kot kvantitativne metodološke predmete. Pogoj je aktivno znanje vsaj angleškega jezika, zelo zaželeno pa je aktivno znanje še kakega drugega velikega tujega jezika. Eng.: The junior researcher will work at the Centre for Public Opinion and Mass Communication Research at the Faculty of Social Sciences and will enroll in the interdisciplinary PhD program in Social Science Methodology at the Faculty of Social Sciences. The thesis will be embedded in a methodological field with a primary focus on cross-national survey research and comparisons of traditional vs modern survey data collection modes.

The young researcher will work in the field of spatial and environmental problematic with emphasis on specific topics related to urban revitalization, sustainable development, urban planning and local/global spatial development. The young researcher will enroll in an interdisciplinary doctoral program at the University of Ljubljana. He/she will be employed at the Center for Spatial Sociology at the Faculty of Social Sciences. The candidate is expected to occasionally participate in the pedagogical process at the Department of Sociology.
