- II. Valid habilitation title Assistant Professor/Associate Professor/Professor in the field of Civil and Commercial Law to the Criteria for Appointment to the Titles of University Teachers, Researchers and Associates at the University of Ljubljana, published at the website of the University of Ljubljana

(https://www.uni-lj.si/en/university/rergulations/habilitacije) candidate meets the listed condition if:

- holds an academic title in required habilitation field at University of Ljubljana; or
- holds an academic title of another institution, under the condition that this title can be recognized as equivalent in accordance to the procedure for the recognition at the University of Ljubljana; or
- fulfils the conditions for appointment to a title of university teacher (Assistant Professor, Associate Professor, or Full Professor in the field of Civil and Commerical Law).
