# CALL FOR ENROLMENT IN FIRST CYCLE AND INTEGRATED MASTER'S STUDY PROGRAMMES IN THE ACADEMIC YEAR 2026/2027

## GENERAL PROVISIONS

On the basis of Article 187 of the Higher Education Act (Official Gazette of the Republic of Slovenia, No. 56/2025; hereinafter: ZViS-1) and the sixth paragraph of Article 21 of the Government of the Republic of Slovenia Act (Official Gazette of the Republic of Slovenia, No. 24/05 – consolidated text, 109/08, 38/10 – ZUKN, 8/12, 21/13, 47/13 – ZDU-1G, 65/14, 55/17, 163/22 and 57/25 – ZF), the Government of the Republic of Slovenia adopted, at its 189th session on 29 January 2026, the following Decision granting consent to the content of the calls for enrolment in first cycle and integrated master's study programmes for the academic year 2026/2027.

### 1. APPLICATION FOR ENROLMENT

#### 1.1 APPLICATION DEADLINES FOR SLOVENIAN NATIONALS, NATIONALS OF THE MEMBER STATES OF THE EUROPEAN UNION, AND SLOVENIANS ABROAD

## CALL FOR ENROLMENT 2026/2027 – GENERAL PROVISIONS

**Applicants are advised to ensure, when completing their application, that they meet or will meet the admission requirements for each study programme; otherwise, the relevant study preference will not be taken into account.**

**Applicants may, in the first and second application deadline, select up to three study programmes in order of priority for which they meet, or will meet by the deadlines published in this call, the admission requirements. The order of the selected study programmes (preferences indicated in the application) is important, as, under the conditions set out in the chapter on the selection procedure of this call, the applicant will be admitted to the first study programme for which they meet all requirements.**

**Information on still-available enrolment study places for the second application deadline will be published on 19 August 2026** on the evš web portal, on the websites of the higher education application and information services of the University of Ljubljana, the University of Maribor, the University of Primorska, the University of Nova Gorica, and on the websites of higher education institutions.

**Applicants whose selection procedure in the first application deadline has not yet been completed** may also submit a second application (including applicants taking the matura in two parts, where the part taken in the autumn examination period is considered, by decision of the competent authority, as a complete matura taken in the spring examination period; applicants taking assessments of special aptitudes, abilities and skills in the autumn period; applicants whose procedure for recognition for the purpose of continuing education has not yet been completed; applicants for whom this has been decided in appeal proceedings; or applicants whose appeal proceedings have not yet been concluded). A second application for enrolment may be submitted from 20 to 27 August 2026. If applicants are admitted to one of the study programmes listed in their first application, the procedure regarding their application in the second application deadline shall be suspended upon their written consent. Applicants shall submit their written consent by the date of publication of the results of the General and Vocational Matura and the Matura examinations in the autumn examination period. If an applicant fails to submit such consent within the period referred to in the preceding sentence, it shall be deemed that they have withdrawn their application in the second application deadline. If applicants are admitted to one of the study programmes in the first application deadline and subsequently enrol in that study programme, their application from the second application deadline shall be excluded from further application and admission procedures and the procedure shall be terminated.

**Information on study programmes for which still-available enrolment study places will be offered under the application deadline for still-available enrolment study places will be published on 22 September 2026** on the evš web portal and on the websites of higher education institutions.

**An application for enrolment under the deadline for still-available enrolment study places** may also be submitted by applicants whose appeal procedure has not yet been concluded and by applicants whose procedure for the recognition of education for the purpose of continuing education has not yet been completed.

### **Application for Slovenians Abroad**

Slovenians abroad shall apply for enrolment to the enrolment study places published in the tables of enrolment study places for Slovenians abroad.

Enrolment study places for enrolment in the first year for Slovenians abroad are determined separately for full-time and part-time study, and the application deadlines are the same as those for nationals of the Republic of Slovenia and nationals of the Member States of the European Union.

Slovenians abroad may submit only one application in the same application deadline, either as a Slovenian abroad or as a national of a Member State of the European Union or as a national of a non-EU Member State.

An applicant who is a Slovenian abroad shall, at the first step of completing the application (“Selection of the call for enrolment and type of application”), answer “YES” to the statement “I am a Slovenian abroad”. At the next step, the applicant must indicate which of the following two categories they belong to:

- Slovenians in neighbouring countries (members of the autochthonous Slovenian national community in all four neighbouring countries – Italy, Austria, Croatia and Hungary);
- Slovenians worldwide and descendants of persons of Slovenian nationality up to the third generation in the direct line (migrants and emigrants residing in neighbouring countries outside the area defined as the Slovenian border region, as well as in other European and non-European countries).

By submitting the application form, the applicant guarantees the accuracy of the information provided in the application for enrolment and thereby confirms that they are a Slovenian abroad, meaning that they fall into one of the two categories listed above. The Higher Education Application and Information Service may request

from applicants who have applied for places for Slovenians abroad the submission of written evidence of Slovenian origin or descent (an extract from the register of births or other appropriate evidence).

### 1.2 APPLICATION DEADLINES FOR FOREIGN NATIONALS FROM NON-EU MEMBER STATES [table of contents](#)

Nationals of non-EU Member States shall apply for enrolment to the enrolment study places published **in the tables of enrolment study places for foreign nationals – nationals of non-EU Member States**. After the end of each application deadline, changes to or withdrawal of individual listed **study preferences shall no longer be possible**.

Higher education institutions may allocate a separate number of available enrolment study places for foreign nationals – nationals of non-EU Member States – from the Western Balkan countries with which the Republic of Slovenia has concluded bilateral agreements in the field of education (Bosnia and Herzegovina, Montenegro, Kosovo, North Macedonia and Serbia)<sup>3</sup>.

**Foreign nationals** shall be required to **pay tuition fees** in accordance with the Rules on Tuition Fees and Accommodation in Public Student Dormitories for Slovenians abroad and for Foreigners in the Republic of Slovenia (Official Gazette of the Republic of Slovenia, Nos. 77/16, 25/19 and 56/22).

On the basis of signed protocols on cooperation in the field of education, nationals of **Montenegro, Kosovo, North Macedonia, Bosnia and Herzegovina**, and **Serbia** shall, for enrolment in the academic year 2026/2027, be treated on an equal footing with nationals of Slovenia and nationals of the Member States of the European Union with regard to the payment of study costs and shall therefore be exempt from paying tuition fees for foreign nationals for full-time study.

If the protocol in the field of education is adopted by the beginning of the academic year 2026/2027, nationals of the Republic of Albania shall be exempt from paying tuition fees for full-time study, subject to the principle of reciprocity.

<sup>4</sup> In the second application deadline, only applicants who hold a decision on the recognition of foreign upper secondary education issued in the first application deadline by the University of Ljubljana and who are not enrolled in a study programme after the completion of the selection procedure in the current academic year may apply for still-available enrolment study places. - applicants holding a decision on the recognition of foreign upper secondary education issued by 2005.
- applicants with an International Baccalaureate or European Baccalaureate.

**Applicants applying for enrolment in a higher year shall submit their electronic application via the evš web portal within the deadlines specified above. Enrolment study places for enrolment in a higher year shall be determined separately by higher education institutions and shall be specified in the call.**

Applications for enrolment in a higher year shall be processed by the competent bodies of higher education institutions:

- in accordance with the transfer criteria specified for individual study programmes for students wishing to change study programmes accredited after 11 June 2004 (so-called Bologna study programmes); or
- in accordance with the procedures of the higher education institution for accelerated progression for applicants who have not completed their previous studies and wish to enrol in the same or a lower year than the one in which they were enrolled in their previous study programme, but not in the first year.

Applicants applying for enrolment in a higher year must also meet the admission requirements for enrolment in the first year of the study programme to which they wish to enrol. The year of study in which an applicant may enrol shall be determined by the higher education institution in the application and admission procedure, regardless of the year selected by the applicant in the application for enrolment.

**Students wishing to pursue parallel study** shall submit their electronic application via the evš web portal within the deadlines specified above. Via the evš web portal, they shall submit to the higher education institution to which they are applying a certificate of completed obligations required for enrolment in a higher year at the higher education institution at which they are already enrolled, and the consent of that (home) institution, if required (applicants obtain this information directly from the relevant higher education institution). The certificate of completed obligations for enrolment in a higher year at the home higher education institution shall be submitted no later than at the time of enrolment.

For Slovenian nationals, nationals of the Member States of the European Union, and Slovenians abroad, no tuition fee shall be charged for enrolment in the first year of a first parallel study programme at the same level for full-time study, provided that the following conditions are met (in accordance with Article 137 of the Higher Education Act):

- the applicant has not yet obtained an education corresponding to at least the level of education of the study programme in which they are enrolling; and
- the applicant enrolls in parallel study before the start of the final year of the first study programme in which they are enrolled on a full-time basis and in which they are progressing regularly.

**Graduates and students who will graduate in the current academic year** may apply for full-time and part-time study in integrated master's study programmes only for places intended for graduates, and for full-time and part-time study in first cycle study programmes within the regular deadlines, in the manner and within the time limits set out in Section 1.1 of this call.

For study at places intended for graduates in integrated master's study programmes, no tuition fee is payable if the applicant has not yet attained the same level of education. If a graduate submits an application for first cycle study programmes within the regular deadlines, payment of tuition fees is required regardless of whether the study is full-time or part-time (in accordance with Article 137 of the Higher Education Act).

Graduates of higher education study programmes under previous regulations and graduates of university and professional higher education study programmes shall submit their electronic application via the evš web portal within the above deadlines. Via the evš web portal, they shall submit to the higher education institution to which they are applying their diploma (an electronic copy of the document, as described in the first paragraph of Section 6 of this call) and a certificate of passed examinations.

Applicants wishing to enrol in study programmes requiring the assessment of **special aptitudes, abilities and skills** must **submit their application between 18 February and 18 March 2026**. The diploma and certificate of passed examinations shall be submitted electronically via the evš web portal to the higher education institution to which the applicant is applying no later than 8 September 2026.

Information for applicants holding foreign education demonstrating fulfilment of the admission requirements is provided in Section 11.

More detailed information on enrolment in a higher year, parallel study, and the enrolment of graduates in integrated master's study programmes may be obtained by applicants from the higher education institution (faculties, academies and professional higher education colleges) at which they wish to continue their studies.

## 2. INFORMATION DAYS

All higher education institutions shall organise Information Days:

- on **Friday, 13 February** and
- on **Saturday, 14 February,**

unless otherwise specified by an individual higher education institution. The exact dates and times shall be published on the evš web portal, on the websites of the higher education application and information services of the University of Ljubljana, University of Maribor, University of Primorska, and University of Nova Gorica, and on the websites of higher education institutions.

Some higher education institutions will organise **several Information Days** as well as **individual information sessions**. Applicants will receive information on these at the first Information Day or on the website of the relevant higher education institution.

At the Information Days, applicants will be able to familiarise themselves in more detail with the admission requirements, study options and conditions, professions and types of work, employment opportunities and opportunities for further education, as well as other information important for making decisions about their studies.

### 3. METHOD OF SUBMITTING THE APPLICATION

Applicants shall submit their application for enrolment by electronic means via the evš web portal at <https://portal.evš.gov.si/prijava/>, **either using an electronic identification tool with at least a substantial level of assurance (qualified digital certificate, smsPASS, electronic identity card), or an AAI account (authentication and authorisation infrastructure account), or a username and password via the SI-PASS system<sup>13</sup>**, which operates within the State Trust Services Centre.

After successful submission of the application, the applicant shall receive a confirmation of successful submission at the email address provided in the application. If the applicant does not receive such confirmation, the application has not been successfully submitted.

**In the application and admission procedures for the academic year 2026/2027, applicants shall submit all required supporting documents** (supplemental documents required under Section 6 and Annex 4 of this call) **electronically via the evš web portal.**

An application shall be considered **timely** if it has been **completed, electronically signed**, and submitted in the evš web portal by the deadline specified in this call.

**Applicants are required to regularly monitor the email address provided in their application and the evš web portal, as all communication and any requests for supplementation of the application are carried out in this manner. Applicants are responsible for ensuring the validity of the email address provided in the application.**

Higher education institutions and higher education application and information services shall serve or make available to applicants the documents and notifications relating to the call for enrolment by depositing the document or notification in the evš web portal (in accordance with Article 57 of the Higher Education Act). Documents and notifications shall be served or made available to applicants by depositing them in the evš web portal in accordance with Article 57 of the Higher Education Act. Applicants shall be informed of the deposit of a document or notification via the evš web portal by means of an informational message sent to the email address provided in the application and, if provided, by a message sent to their mobile phone number. Applicants shall retrieve the document or notification from the evš web portal in electronic form following prior authentication. Upon personal service of a document via the evš web portal, the applicant shall electronically confirm the electronic proof of service. The date of electronic confirmation of the electronic proof of service shall be deemed to be the date of service of the document. If the applicant does not retrieve the document within five days of receiving the informational message regarding the electronically deposited document in the evš web portal, service shall be deemed to have been affected upon expiry of that period.

### 4. ENROLMENT STUDY PLACES

In this call, the number of available enrolment study places for enrolment in the first year, for parallel study, and for graduates applying to integrated master's study programmes is published for each study programme, separately for full-time and part-time study, and jointly for nationals of the Republic of Slovenia (hereinafter: Slovenian nationals) and nationals of the Member States of the European Union. These enrolment study places are also available to nationals of non-EU Member States (hereinafter: foreign nationals) who have permanent residence in the Republic of Slovenia and who themselves or whose parents are tax residents of the Republic

of Slovenia. Enrolment study places are also intended for foreign nationals who have completed upper secondary education in the Republic of Slovenia and passed the matura examination, persons granted international protection and applicants for international protection in accordance with the International Protection Act (Official Gazette of the Republic of Slovenia, No. 16/17 – consolidated text and 54/21), and displaced persons granted temporary protection in accordance with the Temporary Protection of Displaced Persons Act (Official Gazette of the Republic of Slovenia, No. 16/17 – consolidated text). Evidence of the status of persons granted international protection, applicants for international protection, and persons granted temporary protection shall be obtained ex officio by the higher education application and information service from the competent authority, namely the Ministry of the Interior of the Republic of Slovenia.

Nationals of the following non-EU Member States: Norway, Iceland, Liechtenstein, and Switzerland shall be treated in the same manner as Slovenian nationals and nationals of the European Union. From the academic year 2021/2022 onwards, nationals of the United Kingdom shall be enrolled as nationals of non-EU Member States, and their studies shall be subject to the payment of tuition fees.

Enrolment study places are determined separately for Slovenians abroad (see Section [1.1](#)) and for foreign nationals from non-EU Member States (see Section [1.2](#)). Higher education institutions may allocate a separate number of available enrolment study places for foreign nationals from Western Balkan countries with which the Republic of Slovenia has concluded bilateral agreements in the field of education (further information is available from the relevant higher education institutions).

**Enrolment study places for enrolment in a higher year, for parallel study, and for graduates** applying to integrated master's study programmes shall be determined separately by higher education institutions and shall be specified in the call. All applicants, regardless of nationality, may apply for enrolment study places for enrolment in a higher year, whereas only Slovenian nationals, nationals of the Member States of the European Union, and Slovenians abroad may apply for enrolment study places for parallel study and for graduates applying to integrated master's study programmes.

Information for applicants holding foreign education demonstrating fulfilment of the admission requirements is provided in [Section 11](#).

### 5. STUDY PROGRAMMES AND ADMISSION REQUIREMENTS [table of contents](#)

For the 2026/2027 academic year, faculties, academies and professional higher education colleges of universities, as well as public and concession-holding independent higher education institutions, shall publish calls for enrolment in study programmes in accordance with the provisions of the Higher Education Act, as follows:

- **integrated master's study programmes** comprising 300 or 360 ECTS credits and lasting five or six years;
- **first cycle university study programmes** comprising 180 or 240 ECTS credits and lasting three or four years;
- **first cycle professional higher education study programmes** comprising 180 ECTS credits and lasting three years.

Applicants who meet the admission requirements set out in the study programmes and specified in this call may enrol in the study programmes.

**The admission requirements for enrolment in integrated master's study programmes and first cycle university study programmes are as follows:**

- General Matura;
- final examination passed after an appropriate four-year upper secondary education programme before 1 June 1995;
- for certain integrated master's study programmes and first cycle university study programmes, applicants with a Vocational Matura after an appropriate secondary education programme and a passed General Matura examination may also enrol.

**The admission requirements for enrolment in first cycle professional higher education study programmes are as follows:**

- final examination passed after an appropriate four-year upper secondary education programme, General Matura, or Vocational Matura.

For enrolment in certain study programmes, applicants must also pass an **assessment of special aptitudes, abilities and skills**.

For some study programmes, applicants are required to demonstrate proficiency in the language of instruction at the level specified for the individual study programme in the call for enrolment. Information on which study programmes require language proficiency to be assessed upon application is provided in the call for each individual study programme.

Higher education institutions must conduct a **direct interview in order to assess the applicant's suitability in relation to the admission requirements of the study programme**, with a foreign national who has submitted an application for enrolment in higher education in the Republic of Slovenia and who comes from a country with higher migration risk, as determined by the list of countries whose nationals are required to hold visas when crossing the external borders of the European Union, in accordance with the legislation governing the conditions and procedures for the entry, exit and residence of foreigners in the Republic of Slovenia. Where a higher education institution has justified grounds to suspect that an applicant does not demonstrate the level of knowledge indicated in the documents submitted with the application for enrolment, it shall reject the application. No appeal may be lodged against the decision of the higher education institution.

More detailed information on the interview procedure for foreign nationals from non-EU Member States with higher migration risk is provided in Section 12.

### 6. EVIDENCE OF FULFILMENT OF ADMISSION REQUIREMENTS [table of contents](#)

Scanned copies or photographs of original certificates and other required documents shall be accepted as evidence of fulfilment of admission requirements in the application and admission procedure. Applicants shall not send any documents by regular or registered mail; **all required supporting documents must be submitted electronically via the evš web portal.**

Evidence of fulfilment of admission requirements shall be submitted electronically via the evš web portal.

1. Applicants **taking the General Matura, the Vocational Matura, or individual General Matura examinations in the winter, spring, or autumn examination period in the year in which they submit their application for enrolment shall not submit certificates from the third and fourth years of secondary school or certificates of completed Matura.** Data from third- and fourth-year certificates for subjects taken by the applicant in the Matura, as well as data from the General Matura certificate, Vocational Matura certificate, and notifications of passed individual General Matura examinations, shall be provided to the higher education application and information service by the National Examination Centre no later than by the deadline specified in the General Matura calendar or the Vocational Matura calendar.

Applicants who passed the **General Matura from 1995** onwards and applicants who passed the **Vocational Matura from 2002 onwards shall not submit** General Matura certificates, Vocational Matura certificates, or notifications of passed individual General Matura examinations.

For grade data that cannot be obtained from the National Examination Centre (e.g. grades in subjects not taken as part of the Matura), the higher education application and information service shall contact applicants directly via the evš web portal.

2. Applicants who **completed secondary school with a final examination** shall submit the final examination certificate and certificates from the third and fourth years of secondary school.
3. Applicants who enrolled in four-year secondary education programmes between the 1981/82 and 1985/86 school years and completed them by **31 August 1991** or **31 August 1992** shall submit their **diploma** as evidence of completed secondary education and certificates from the final two years of secondary school.
4. A **certificate of the final examination – trial Matura (from 1994)** shall also be recognised as a General Matura certificate.
5. Applicants whose overall achievement in the third and fourth years is recorded in their **student record book** shall submit, as evidence, the first page of the record book and the pages indicating the grades for each year and the overall achievement for each year.
6. Applicants who already hold a **diploma of the International Baccalaureate (IB)** or the **European Baccalaureate** shall submit this document as evidence. For applicants who will take the International Baccalaureate or the European Baccalaureate in Slovenia in the current year, secondary schools shall, on the basis of the applicant's consent, submit data on overall achievement **by 10 July 2026**. Applicants who

will take these examinations abroad must submit their certificates no later than **31 July 2026 in the first application deadline and by 27 August 2026 in the second application deadline.**

Under the Matura Examination Act, the International Baccalaureate diploma is equivalent to the General Matura certificate in the Republic of Slovenia without a recognition procedure. Applicants who receive an IB certificate must undergo the procedure for recognition of education for the purpose of continuing education.

7. Under the Act Regulating the Implementation of International Programmes in Education, the **European Baccalaureate Certificate** is equivalent to a public document on the completion of education issued under publicly recognised education programmes, and no recognition procedure is required. For applicants who have completed secondary education under the European Schools programme, grades from the European Baccalaureate certificate or annual certificates shall be converted into grades under the Slovenian upper secondary grading scale in accordance with the regulation governing the conversion of grades under the European Schools programme.
8. The National Examination Centre shall provide the higher education application and information service with all data on academic achievement in accordance with the **General Matura or Vocational Matura calendar.**
9. Higher education institutions shall enter data on assessments of special aptitudes, abilities and skills in the eVŠ system by **10 July 2026** in the first application deadline and by **14 September 2026** in the second application deadline.
10. Applicants who are **nationals of the Republic of Slovenia, nationals of the Member States of the European Union, and Slovenians abroad** and who already hold certificates obtained abroad shall submit them electronically via the evš web portal as follows:
  - in the first application deadline, applicants shall submit supporting documents, namely an electronic copy or photograph of the final certificate and certificates from the final two years of secondary school together with the application or no later than 18 March 2026; other evidence of fulfilment of admission requirements, such as proof of proficiency in Slovenian, shall be submitted by 31 July 2026;
  - in the second application deadline, applicants shall submit supporting documents, namely an electronic copy or photograph of the final certificate and certificates from the final two years of secondary school together with the application or no later than 27 August 2026. Applicants shall submit translations of documents only upon request by the higher education application and information service.

Applicants who will complete secondary education abroad in the current year must submit electronic copies or photographs of the final certificate, certificates from the final two years of secondary school, and translations of these certificates, where required for the first and second application deadline, electronically via the evš web portal as soon as the final certificate is issued, and **no later than 31 July 2026 in the first application deadline or 27 August 2026 in the second application deadline.** The higher education application and information service shall obtain the decision on the recognition of foreign upper secondary education ex officio.

Decisions on the recognition of education for the purpose of continuing education shall be issued by universities or by public and concession-holding independent higher education institutions (see [Section 11](#)).

Applicants applying for studies on the basis of foreign upper secondary school certificates shall submit, via the evš web portal, the following documents for the application and recognition procedures ([Annex 4](#)):

1. An electronic copy or photograph of the document(s) on completed education abroad which the applicant wishes to have recognised for the purposes of the application and admission procedure;
2. An electronic copy or photograph of a court-certified translation of the document(s) on education referred to in point 1 into Slovenian or English. If the applicant is required to submit a translation, they will be subsequently notified via the evš web portal;
3. An electronic copy or photograph of evidence of the content and duration of education and of completed obligations during education (e.g. annual certificates for all years of secondary school). If the applicant is required to submit translations of such evidence, they will be subsequently notified via the evš web portal;
4. An electronic copy or photograph of a brief chronological description of the applicant's entire education relevant to the application and recognition procedure (to be written in a few sentences, including years, describing the course of the applicant's education to date);

5. An electronic copy or photograph of proof of having passed a Slovenian language proficiency examination at the required level, or other appropriate evidence – only in cases where this is an admission requirement for the study programme;
- 6.<sup>14</sup> An electronic copy or photograph of an identity document on the basis of the applicant's written consent, if required.
  - national of a Member State of the European Union: identity card or passport (the page containing the applicant's personal data, including first name, surname, date and place of birth, and citizenship);
  - foreign national from a non-EU Member State: passport (the page containing the applicant's personal data, including first name, surname, date and place of birth, and citizenship).
7. Additional evidence: the authority responsible for the recognition of education may require the applicant to submit additional documents if necessary for the assessment of the application. In such cases, the applicant shall be requested to submit the additional documents via the evš web portal.
11. For certificates obtained in the former Yugoslav republics **before 25 June 1991**, the recognition procedure is not required.

Applicants who are required to submit supplemental documents to their application shall submit them electronically via the evš web portal to the higher education application and information services.

Supplemental documents to the application for enrolment may be submitted together with the application or subsequently, but no later than the deadline specified in the call for enrolment. Applicants are advised to pay attention to the final date for electronic submission of supplemental documents, as submission will no longer be possible after that date. If an applicant experiences technical or other difficulties in submitting the required supplemental documents via the evš web portal, they should report this to the first-level applicant support service at [ekc@gov.si](mailto:ekc@gov.si) (please note that requests for assistance are handled during official office hours); otherwise, complaints regarding technical issues in submitting supplemental documents will not be considered. Each applicant may upload a maximum of four (4) files per attachment, with a maximum file size of 5 MB per file.

### 8. ASSESSMENT OF SPECIAL APTITUDES, PSYCHOPHYSICAL ABILITIES AND SKILLS, AND INDIVIDUAL GENERAL MATURA EXAMINATIONS TABLE OF CONTENTS [table of contents](#)

**Assessments of special aptitudes, psychophysical abilities and skills** shall be conducted at higher education institutions in accordance with the schedule set out in the [annex](#) Assessments of Special Aptitudes, Psychophysical Abilities and Skills for the 2026/2027 Academic Year, namely in the first application deadline from **24 June to 8 July 2026**. In the second application deadline, assessments of special aptitudes, abilities and skills shall be conducted from **4 to 10 September 2026**. **The exact dates of the assessments are specified in the call for enrolment for each individual study programme.** If assessments are not conducted, applicants who have already passed the assessment in the first application deadline may apply for such study programmes.

Applicants shall be notified of the assessments of special aptitudes, psychophysical abilities and skills at least **five days prior to the assessment** in the first application deadline and at least **two days prior to the assessment** in the second application deadline. Notifications shall be sent by higher education institutions to the email address provided by the applicant in the application for enrolment.<sup>15</sup>

Applicants who will be invited to the assessments of special aptitudes, psychophysical abilities and skills are those who:

- listed, as their first preference, a study programme requiring such an assessment;
- listed, as their second or third preference, a study programme requiring such an assessment, and as their first preference a study programme with restricted enrolment;
- listed, as their first, second or third preference, a study programme for which such an assessment is required and for which, exceptionally, enrolment is possible despite not meeting the standard admission requirements, provided that exceptional talent is demonstrated.

More detailed information on these assessments may be obtained from the relevant higher education institution.

Higher education institutions shall issue applicants with a notification of completed assessments and shall enter the results in the eVŠ system.

Applicants who are granted permission by the competent body of a higher education institution or independent higher education institution for justified reasons, and applicants for whom this is decided in appeal proceedings, may exceptionally take the assessments of special aptitudes, psychophysical abilities and skills in the autumn examination period or within deadlines determined by the higher education institutions. In such cases, an assessment taken in the autumn examination period by the applicant shall be considered as an assessment completed in the first application deadline. These applicants shall subsequently be ranked within the first application deadline.

Applicants who have already passed the General Matura or the Vocational Matura, applicants who are taking the Vocational Matura, applicants whose certificate obtained abroad has been recognised in the procedure for recognition for the purpose of continuing education as a Matura certificate, and other applicants may take **individual General Matura examinations**, provided that these subjects are an admission requirement for an integrated master's or university study programme and are taken into account in the selection procedure.

The examinations shall be taken within the deadlines specified in the General Matura calendar. Applicants **must register for the examinations themselves** with the National Examination Centre or with secondary schools offering general upper secondary (gimnazija) programmes, within the deadlines laid down in the regulations governing the General Matura.

Notifications of passed individual General Matura examinations issued by the National Examination Centre shall be permanently valid.

### 9. ENROLMENT RESTRICTION AND SELECTION CRITERIA [table of contents](#)

If the number of applicants applying in the first application deadline for enrolment in study programmes listed as their first preference exceeds the announced number of available enrolment study places by 10% or more, universities and public and concession-holding independent higher education institutions shall adopt a decision on restricted enrolment.

Data on the number of applications for individual study programmes in the first application deadline shall be published on the evš web portal and on the websites of the higher education application and information services no later than **25 March 2026**.

If, in the second application deadline, the number of applicants applying for enrolment in study programmes listed as their first preference exceeds the number of still-available enrolment study places, enrolment in the study programme shall be restricted and applicants shall be selected in accordance with the selection criteria applicable in cases of restricted enrolment, as determined by the study programme.

The same shall apply to applications submitted under the application deadline for still-available enrolment study places, applications for enrolment in a higher year, parallel study and applications by graduates to integrated master's study programmes, as well as to application deadline for Slovenians abroad and for foreign nationals from non-EU Member States.

- For enrolment in **first cycle professional higher education and university study programmes and in integrated master's study programmes** for which a decision on restricted enrolment has been adopted, the selection criteria laid down in the study programme and published in the call shall apply.
- For applicants who, upon completion of four-year vocational secondary education, obtained a diploma, the achievement in the third and fourth years shall be taken into account as the overall achievement of the final certificate, in the proportion of points specified for the final examination for each individual study programme.
- For applicants who have completed a **five-year secondary education programme**, the achievement in the fourth and fifth years shall be taken into account instead of the achievement in the third and fourth years.
- Applicants who have completed education under **continuing education programmes or vocational-technical education programmes** shall be awarded, for achievement in the first and second years of such programmes, the same proportion of points as specified for the third and fourth years for the relevant study programme.
- For applicants who complete a **Matura course** after completing the fourth year of secondary education, achievement in the third and fourth years and achievement in the General Matura shall be taken into account in the selection procedure. For those who complete a Matura course after three years of secondary education or less, only the Matura certificate shall be taken into account. For applicants, achievement in the General Matura shall be taken into account in place of achievement in the third and fourth years, in the proportion of points specified for the relevant study programme for the third and fourth years.
- For applicants who complete education under the **vocational course** programme, achievement in the third and fourth years of a general upper secondary (gimnazija) programme or a secondary technical education programme and achievement in the Vocational Matura shall be taken into account in the selection procedure.
- For applicants who have taken or will take the **General Matura without completing the third and fourth years of secondary education**, achievement in the General Matura shall be taken into account in place of achievement in the third and fourth years, in the proportion of points specified for the relevant study programme.
- For applicants holding an **International Baccalaureate (IB)** diploma, achievement in the General Matura shall be taken into account in place of achievement in the third and fourth years, in the proportion of points specified for the relevant study programme. Proof of successful completion of the International Baccalaureate shall be the IB diploma or the IBO Results Summary (if the diploma has not yet been awarded), bearing the endorsement: "Diploma Awarded" or "Bilingual Diploma Awarded".
- For applicants holding a **European Baccalaureate Certificate**, grades from the European Baccalaureate certificate or annual certificates shall be converted into grades under the Slovenian upper secondary grading scale in accordance with the regulation governing the conversion of grades under the European Schools programme.
- Applicants whose **prior formal or non-formal knowledge has been recognised within an appropriate secondary education programme without being graded** shall be awarded 0 (zero) points in the selection procedure. Information on options for obtaining a grade may be obtained by applicants from secondary schools.

Where different types of evidence of fulfilment of admission requirements are acceptable for enrolment in a study programme, the evidence that is more favourable to the applicant shall be taken into account in the selection procedure.

**For the conversion of secondary education grades in the calculation of points in cases of restricted enrolment**, the following shall be applied:

### 10. SELECTION PROCEDURE FOR SLOVENIAN NATIONALS, NATIONALS OF THE MEMBER STATES OF THE EUROPEAN UNION, AND SLOVENIANS ABROAD

#### 10.1 FIRST APPLICATION DEADLINE

Applicants who list, as their **first preference** in the first application, a study programme for which **no decision on restricted enrolment has been adopted** shall be admitted to that programme if they meet the general admission requirements.

Applicants who list, as their **first preference** in the first application, a study programme for which a **decision on restricted enrolment has been adopted** shall be admitted to that programme or to the next restricted-enrolment study programmes listed in their application if they meet the general admission requirements and achieve a sufficient number of points, and to still-available places in study programmes without restricted enrolment if they meet the general admission requirements.

If too many applicants who listed a study programme without restricted enrolment as their second or third preference apply for **still-available enrolment study places** in that programme, they shall be selected in accordance with the criteria applicable in cases of restricted enrolment, as determined by the study programme.

If all places in a study programme for which no decision on restricted enrolment has been adopted are filled by applicants who listed it as their first preference, applicants who listed it as their second or third preference may not be admitted to that programme.

Applicants who have achieved the same number of points as the last admitted applicant shall be included on the list of admitted applicants, regardless of the number of available enrolment study places determined by the decision on restricted enrolment.

**Decisions on the results of the selection procedure for Slovenian nationals and nationals of the Member States of the European Union shall be published no later than 24 July 2026, and for Slovenians abroad no later than 5 August 2026, on the evš web portal (applicants may access the decision on the results of the selection procedure via their user account on the evš web portal at <https://portal.evs.gov.si/prijava>).**

Applicants shall retrieve the document or notification from the evš web portal in electronic form following prior authentication. An applicant shall be deemed to have been informed of the content of a document or notification upon logging in to the evš web portal. Upon personal service of a document via the evš web portal, the applicant shall electronically confirm the electronic proof of service. The date of electronic confirmation of the electronic proof of service referred to in the preceding sentence shall be deemed to be the date of service of the document. If the applicant does not retrieve the document within five days of receiving the informational message regarding the electronically deposited document in the evš web portal, service shall be deemed to have been effected upon expiry of that period.

The following applicants shall **subsequently** be included on the list of admitted applicants:

- applicants who, for justified reasons and in accordance with decisions of the authorities competent for the General Matura or the Vocational Matura, take the Matura in two parts, whereby the part taken in the autumn examination period is considered as a complete Matura taken in the spring examination period;
- applicants for whom the National Examination Centre provides amended data (General and Vocational Matura appeals);
- applicants who, in accordance with a decision of the competent authority of a faculty, academy or professional higher education college, take assessments of special aptitudes, abilities and skills in the autumn examination period;

- applicants who are Slovenian nationals, nationals of the Member States of the European Union, or Slovenians abroad, who completed secondary education abroad and whose recognition procedure under the legislation governing the evaluation and recognition of education has not yet been completed;
- applicants for whom such inclusion has been decided in appeal proceedings or extraordinary legal remedy proceedings.

Applicants referred to above who meet the general admission requirements shall be included among the admitted applicants if they applied for a study programme **without restricted enrolment** or if they achieve **at least the same number of points as the last admitted** applicant on the list.

**Applicants with special needs and applicants with special status shall also be subsequently included** on the list of admitted applicants if, in the first selection procedure, they meet the general admission requirements for the study programme, were not admitted to any of the listed programmes **in the regular selection procedure**, and achieve at least 90% of the minimum number of points required for admission.

The higher education application and information service shall inform subsequently admitted applicants and the higher education institutions to which they have been admitted of the results of the selection procedure electronically via the evš web portal no later than 21 September 2026. A decision shall be deemed to have been served on the applicant on the second working day following the date of publication of the decision on the evš web portal. Decisions on the results of the selection procedure and other documents for subsequently admitted applicants shall be served in the same manner as described above.

### 10.2 SECOND APPLICATION DEADLINE

Applicants who, in the second application, list as their first preference a study programme for which the number of applicants listing it as their first choice does not exceed the number of available enrolment study places shall be admitted to that programme if they meet the general admission requirements.

If the number of applications for a study programme listed as the first preference in the second application exceeds the number of available places, applicants shall be selected in accordance with the procedure set out in Section “[10.1. Selection Procedure – First application deadline](#)” and in compliance with the criteria applicable in cases of restricted enrolment, as determined by the study programme.

**Decisions on the results of the selection procedure for Slovenian nationals, nationals of the Member States of the European Union, and Slovenians abroad shall be published on the evš web portal no later than 21 September 2026 (applicants may access the decision via their user account at <https://portal.evš.gov.si/prijava>).** Applicants shall retrieve the document or notification from the evš web portal in electronic form following prior authentication. An applicant shall be deemed to have been informed of the content of a document or notification upon logging in to the evš web portal. Upon personal service of a document via the evš web portal, the applicant shall electronically confirm the electronic proof of service. The date of electronic confirmation of the electronic proof of service referred to in the preceding sentence shall be deemed to be the date of service of the document. If the applicant does not retrieve the document within five days of receiving the informational message regarding the electronically deposited document in the evš web portal, service shall be deemed to have been effected upon expiry of that period.

Applicants for whom such inclusion has been decided in appeal proceedings shall subsequently be included on the list of admitted applicants. Such applicants who meet the general admission requirements shall be included among the admitted applicants if they applied for a study programme **without restricted enrolment** or if they achieve **at least the same number of points as the last-ranked applicant** on the list of admitted applicants.

**Applicants with special needs and applicants with special status shall also be subsequently included** on the list of admitted applicants if, in the second application deadline, they meet the general admission requirements for the study programme, were not admitted to any of the listed programmes in the regular selection procedure, and achieve at least 90% of the minimum number of points required for admission. Decisions on the results of the selection procedure and other documents for subsequently admitted applicants shall be served in the same manner as described above.

### 10.3 APPLICATION DEADLINE FOR STILL-AVAILABLE ENROLMENT STUDY PLACES [table of content](#)

If the number of applications exceeds the number of still-available enrolment study places under the deadline for still-available enrolment study places, applicants shall be selected in accordance with the criteria applicable in cases of restricted enrolment, as determined by the study programme.

The status of an applicant with special needs or special status granted in the first or second application deadline shall also be taken into account in this period (the applicant must submit the relevant evidence electronically via the evš web portal within the application deadline referred to in [Section 1](#) of this call). The granting of the status of an applicant with special needs or special status in this period is not possible.

**Decisions on the results of the selection procedure shall be published on the evš web portal no later than 25 September 2026 (applicants may access the decision via their user account at <https://portal.evs.gov.si/prijava/>).** Applicants shall retrieve the document or notification from the evš web portal in electronic form following prior authentication. An applicant shall be deemed to have been informed of the content of a document or notification upon logging in to the evš web portal. Upon personal service of a document via the evš web portal, the applicant shall electronically confirm the electronic proof of service. The date of electronic confirmation of the electronic proof of service referred to in the preceding sentence shall be deemed to be the date of service of the document. If the applicant does not retrieve the document within five days of receiving the informational message regarding the electronically deposited document in the evš web portal, service shall be deemed to have been effected upon expiry of that period.

### 11. PROCEDURE FOR THE RECOGNITION OF EDUCATION FOR THE PURPOSE OF CONTINUING EDUCATION IN THE REPUBLIC OF SLOVENIA FOR APPLICANTS HOLDING FOREIGN EDUCATION:

- OF COMPLETED SECONDARY EDUCATION
- OF COMPLETED YEAR OF STUDY FOR CONTINUATION OF STUDIES AND ENROLMENT IN A HIGHER YEAR
- OF GRADUATES [table of content](#)

Applicants who demonstrate fulfilment of admission requirements on the basis of completed foreign secondary education are hereby informed that their certificate of completed education is subject to recognition under the [Act Regulating the Evaluation and Recognition of Education](#) (Official Gazette of the Republic of Slovenia, Nos. 87/11, 97/11 – corr., and 109/12).

In such cases, the electronic application for enrolment also constitutes an application for the recognition of education for the purpose of continuing education in the Republic of Slovenia. The form shall be submitted in the eVŠ system via the **online portal**: <https://portal.evs.gov.si/prijava/>. Applicants who submit an incomplete application for enrolment or an incomplete application for recognition of education for the purpose of continuing education shall be individually notified electronically via the evš web portal of the requirement and deadline for supplementing the application. Applicants shall retrieve the document or notification from the evš web portal in electronic form following prior authentication. An applicant shall be deemed to have been informed of the content of a document or notification upon logging in to the evš web portal. Upon personal service of a document via the evš web portal, the applicant shall electronically confirm the electronic proof of service. The date of electronic confirmation of the electronic proof of service referred to in the preceding sentence shall be deemed to be the date of service of the document. If the applicant does not retrieve the document within five days of receiving the informational message regarding the electronically deposited document in the evš web portal, service shall be deemed to have been effected upon expiry of that period.

The list of required documents to be attached to the application for enrolment and to the application for recognition of education for the purpose of continuing education is provided in [Annex 4](#). The required documents must be submitted via the evš web portal no later than the deadline for supplementation. Subsequent supplements and amendments are not possible. Documents shall also be deemed to have been submitted on time if they are sent by registered mail no later than on the day the deadline for supplementation expires.

As the list of required documents may vary depending on the country of origin of the educational certificate, applicants are advised to obtain prior information on the detailed list of documents and on the procedure from the authorised persons at the universities at the contact details below:

Applicants applying for **enrolment in a higher year** of first cycle or integrated master's study programmes shall **obtain information on the procedures for the recognition of foreign education directly from the higher education institution to which they are submitting their application.**

### WARNING

**The deadline for issuing a decision on recognition** in accordance with the Act Regulating the Evaluation and Recognition of Education (Official Gazette of the Republic of Slovenia, Nos. 87/2011, 97/2011 – corr., and 109/12) is no later than **two months from receipt of a complete application.**

Applicants must observe the deadlines set for the submission of evidence of fulfilment of admission requirements in the application and admission procedure. Applications that are not supplemented by the deadline specified in the request for supplementation shall be dismissed in accordance with the General Administrative Procedure Act and shall not be included in the selection procedure.

## 12. INTERVIEW TO ASSESS THE SUITABILITY OF APPLICANTS FROM COUNTRIES WITH HIGHER MIGRATION RISK

Before proceeding with the further professional and administrative processing of an application for enrolment, higher education institutions must **conduct a direct interview to assess the suitability of a foreign national** who has submitted an application for enrolment in higher education in the Republic of Slovenia<sup>16</sup> and who comes from a country with higher migration risk, as determined by the list of countries whose nationals are required to hold visas when crossing the external borders of the European Union, in accordance with the legislation governing the conditions and procedures for the entry, exit and residence of foreigners in the Republic of Slovenia.

Where a higher education institution has justified grounds to suspect that an applicant does not demonstrate the level of knowledge indicated in the documents submitted with the application for enrolment, it shall issue a decision rejecting the application. No appeal may be lodged against the decision of the higher education institution. By issuing a rejection decision, all procedures related to the applicant's application for enrolment shall be terminated in their entirety.

Where, following the interview, the higher education institution determines that the applicant is suitable in relation to the admission requirements of the study programme, it shall record the successful completion of the interview in the eVŠ system and continue with the professional and administrative processing of the application.

All costs incurred by the higher education institution in conducting the interview abroad or remotely shall be borne in full by the applicant.

More detailed information on the interview procedure may be obtained by applicants from the higher education institution (faculties, academies and professional higher education colleges) at which they wish to continue their studies.

### 13. AWARDING OF THE STATUS OF APPLICANTS WITH SPECIAL NEEDS AND THE STATUS OF APPLICANTS WITH SPECIAL STATUS IN THE APPLICATION AND ADMISSION PROCEDURE

Applicants may apply for the status of an applicant with special needs and the status of an applicant with special status in the application and admission procedure at the same time as submitting their application for enrolment. In the application, they must indicate that they wish to apply for the status of an applicant with special needs and special status (this is indicated when completing the application at the step “Verification of data on previous higher education”, by answering “YES” to the fourth statement, which reads: “I wish to apply for the status of an applicant with special needs and special status”). Applicants shall attach to their **application** documents proving that they are:

- blind or partially sighted applicants or applicants with visual impairment, deaf or hard-of-hearing applicants, deafblind applicants, applicants with speech and language disorders, applicants with specific learning difficulties, applicants with physical disabilities, applicants with long-term illnesses, applicants with autism spectrum disorders, and applicants with psychosocial difficulties;
- applicants who are categorised athletes and coaches, recognised artists and cultural workers, other applicants participating in (discipline-specific) international competitions, and applicants who are parents until the start of their child’s compulsory schooling.

**Special needs shall be taken into account if they arose by the completion of secondary school.**

**Special status shall be taken into account if it existed during the period relevant for admission (third or fourth year or completion of secondary school).**

**Applicants shall submit supporting documents via the evš web portal when completing their application, or subsequently electronically via the evš web portal, but no later than the following deadlines:**

- in the **first application deadline, no later than 1 June 2026**. The status of an applicant with special needs and special status granted in the first application deadline shall also be taken into account in the second application deadline and in the deadline for still-available enrolment study places;
- in the **second application deadline, no later than 27 August 2026**. The status of an applicant with special needs and special status granted in the second application deadline shall also be taken into account in the deadline for still-available enrolment study places.

The granting of the status of an applicant with special needs and special status in the deadline for still-available enrolment study places is not possible.

The university authority shall adopt rules governing the granting of the status of an applicant with special needs and the status of an applicant with special status in the application and admission procedure.

The competent authority of the university or of public and concession-holding independent higher education institutions shall decide on the granting of the status and shall notify the applicant via the evš web portal.

Decisions of the competent authorities of universities and of public and concession-holding independent higher education institutions regarding applicants with special needs and special status shall apply only to the application and admission procedure under this call in the first and second application deadline and in the application deadline for still-available enrolment study places.

- Higher education institution of University of Novo Mesto, New University, Alma Mater Europaea University, or a public or private higher education institution offering concession-based study programmes, if that study programme is listed as the first preference in the application form.

**Applicants** are advised to familiarise themselves with the relevant information before completing the application.

### 14. ENROLMENT

[table of contents](#)

Enrolment is carried out at higher education institutions, which invite applicants to enrol either in writing or electronically. Enrolment is completed on the basis of a completed enrolment form.

Enrolment of applicants admitted in the first application deadline will take place **from 24 July until no later than 14 August 2026**. Enrolment of applicants admitted in the second application deadline will take place **from 21 to 30 September 2026**. Enrolment of applicants admitted under the application deadline for still-available enrolment study places will take place by **30 September 2026**, and, for justified reasons determined by the competent authority of the higher education institution, **no later than 30 October 2026**, if so decided by the competent authority upon the applicant's request.

After the deadlines referred to in the preceding paragraph, enrolment shall also take place for admitted applicants who applied for enrolment in a higher year (pursuant to transfer criteria or under conditions for accelerated progression), for parallel study, or for enrolment of graduates in integrated master's study programmes.

A student who withdraws from a first enrolment in the first year of a first cycle or integrated master's study programme by 15 October 2026 shall be deemed not to have enrolled in that study programme.

### 15. NOTICE TO ALREADY ENROLLED STUDENTS

Students who wish to change their study programme and who have not yet exercised this right or their right to repeat a year must apply in the same way as other applicants. This also applies to students who wish to change the mode of study within the same study programme in the first year. Both groups shall submit their application for enrolment via the [eVŠ online portal \(https://portal.evs.gov.si/prijava/\)](https://portal.evs.gov.si/prijava/)

Applicants who have **already repeated a year once or have already changed** their study programme once may apply for full-time study; however, tuition fees shall be payable for their studies in accordance with Article 137 of the Higher Education Act.

Applicants who wish to repeat the first year of a study programme in which they were enrolled in previous years shall not submit an application for enrolment via eVŠ. For re-enrolment in the same year of a study programme in which they are already enrolled, applicants must meet the conditions for repeating the year. Information on the procedure and conditions for enrolment for the purpose of repeating a year may be obtained by students from their higher education institution. The same applies to progression to a higher year in a study programme in which the applicant is already enrolled.

Applicants may re-enrol once in a study programme or specialisation in which they were previously enrolled and from which they withdrew. Such applicants shall submit an individual request directly to the higher education institution and not via eVŠ. Tuition fees shall be charged for studies referred to in the preceding sentence (paragraph 7 of Article 137 of the Higher Education Act). ### 16. EXPLANATION REGARDING THE PAYMENT OF TUITION FEES IN ACCORDANCE WITH ARTICLE 137 OF THE HIGHER EDUCATION ACT

Tuition fees for full-time study may not be charged to citizens of the Republic of Slovenia and citizens of the Member States of the European Union for education provided within first cycle and postgraduate study programmes with public validity that are delivered as a public service financed from public funds.

Notwithstanding the preceding paragraph, citizens of the Republic of Slovenia and citizens of the Member States of the European Union shall be charged tuition fees if they have already attained an educational education at least equivalent to the level of education obtained under the study programme in which they are enrolled.

Under the same conditions as Slovenian citizens (i.e. without payment of tuition fees for full-time study), the following persons may also study at higher education institutions in the Republic of Slovenia:

- Slovenians abroad;
- foreign nationals from non-EU countries who have completed secondary education and passed the Matura in the Republic of Slovenia;
- foreign nationals from non-EU countries who have permanent residence in the Republic of Slovenia and who, or whose parent or guardian, are tax residents of the Republic of Slovenia by the start of the selection procedure;
- persons with recognised international protection, applicants for international protection, and displaced persons with temporary protection;
- nationals of the following non-EU countries: Norway, Iceland, Liechtenstein and Switzerland.

On the basis of signed protocols on cooperation in the field of education, nationals of Montenegro, Kosovo, North Macedonia, Bosnia and Herzegovina, and Serbia shall, for enrolment in the academic year 2026/2027, be treated on an equal footing with nationals of Slovenia and nationals of the Member States of the European Union with regard to the payment of study costs and shall therefore be exempt from paying tuition fees for foreign nationals for full-time study.

Tuition fees shall also be charged to students who have not yet attained an education at least equivalent to the level of education obtained under the study programme in which they are enrolled, and who have already exhausted the right referred to in the second or third indent of the first paragraph of Article 111 of the Higher Education Act (i.e. have already changed their study programme or specialisation, or repeated any year at the same level of study), unless they enrol in a higher year than that in which they were previously enrolled at the same level of study.

Applicants who have already repeated a year once or changed their study programme once may apply for and be admitted to full-time study; however, tuition fees shall be payable in accordance with Article 137 of the Higher Education Act. Tuition fees shall not be charged only if the student enrolls in a higher year than that in which they were previously enrolled at the same level of study.

  - Vocational Matura with a possible maximum of 20 points: the points for overall achievement obtained in the Vocational Matura are taken into account (for the subject Slovene, the grade is converted according to the scale in the column “Scale 2–8” and the difference in points is added) In the case of an additional General Matura subject (the so-called fifth General Matura subject) the points achieved in that subject are also taken into account in the selection procedure.
- (2) The scale is also used for scoring the final examination taken before 1 June 1995 with three subjects, whereby the sum of all grades, which may amount to a maximum of 15, is recalculated to 20.
- (3) The 2–8 scale is used for scoring achievement in the subject of the mother tongue (Slovene, Hungarian, Italian), for other languages in ethnically mixed areas, and for subjects in the General Matura that are also assessed at a higher level of difficulty (mathematics and foreign languages).
- (4) The 2–5 scale is used for scoring achievement in General Matura subjects that are assessed only at the basic level of difficulty.

### ANNEX 6: Rules for the evaluation of upper secondary school achievement based on foreign certificates

#### 1. General provisions

[table of contents](#)

For all foreign certificates, a procedure for the recognition of education for the purpose of continuing education in integrated master's, university, or professional higher education study programmes must be carried out.

Pursuant to the [Assessment and Recognition of Education Act](#) (Official Gazette of the Republic of Slovenia, No. 87/11 et seq.), the recognition procedure is conducted by authorised persons of universities or independent higher education institutions, who issue a decision on the recognition of the right to continue education. The decision specifies how a foreign educational certificate is to be treated in cases of restricted enrolment and indicates the comparable form of completion of secondary education in Slovenia.

On the basis of the recognition decision, the Higher Education Application and Information Service (hereinafter: VPIS) determines whether an individual meets the general admission requirements for the study programmes selected in their application.

If a decision on restricted enrolment has been adopted for a particular study programme, VPIS must evaluate the individual's academic achievement and grades obtained in secondary education. In assessing foreign certificates, it takes into account the grading scales of foreign secondary education systems.

In the event of deviations from the Rules on the Evaluation of Foreign Secondary School Certificates, the evaluation of secondary school achievement shall take into account the specific characteristics of the individual education system and the grade conversion scale developed for that system.

In doing so, the education and grading system of the foreign country is compared with the regulations applicable in Slovenia:

- the Matura Examination Act (Official Gazette of the Republic of Slovenia, No. 29/08 et seq.),
- the General Matura Rules (Official Gazette of the Republic of Slovenia, No. 29/08 et seq.),
- the Rules on the Assessment of Knowledge in Secondary Schools (Official Gazette of the Republic of Slovenia, No. [30/18](#)),
- the Rules on the Implementation of the International Baccalaureate Education Programme (Official Gazette of the Republic of Slovenia, No. 67/04 et seq.),
- the Vocational Matura Rules (Official Gazette of the Republic of Slovenia, No. 99/01 et seq.),
- the Rules on the Integration of Programmes from European Schools into the Slovenian Education System (Official Gazette of the Republic of Slovenia, No. [25/17](#)).
- Grade Conversion Table for Scoring in Enrolment Restriction Procedures for First cycle University Study Programmes and Integrated Master's Study Programmes,
- Grade Conversion Table for Scoring in Enrolment Restriction Procedures for First cycle Higher Education Study Programmes.

#### 2. Grade Conversion

The following rules shall be applied when converting grades. In individual cases, grade conversion may be adjusted to the specific characteristics of the foreign grading system.

- A scale with **three positive grades** is assessed as follows: the highest foreign grade is equivalent to the highest Slovenian grade (5 – excellent), the lowest foreign passing grade is equivalent to the lowest Slovenian passing grade (2 – sufficient), and the third (intermediate) grade is equivalent to 3.5 (70 standardised points), which corresponds to the Slovenian grade 4 (very good).
- A scale with **four positive grades**, regardless of whether they are expressed numerically, by letters, words or percentages, is assessed in accordance with the Slovenian four-level scale of positive grades (excellent, very good, good, sufficient).
- A scale with **five positive grades** is converted into a four-level scale. If grades on the certificate are also described in words, this shall be taken into account (e.g. the two highest grades are “excellent” – Italy). If such descriptions are not provided, the rule applied in higher education shall be used: the highest grade is “excellent”, the next two are “very good”, the fourth is “good”, and the fifth is “sufficient”.

## CALL FOR ENROLMENT 2026/2027 – GENERAL PROVISIONS

- A scale with **six positive grades** is converted into a four-level scale. If grades on the certificate are also described in words, this shall be taken into account; otherwise, the International Baccalaureate (IB) scale shall be used as a reference: **6 and 7** = excellent (5), **5** = very good (4), **4** = good (3), **3 and 2** = sufficient (2), **1** = insufficient (1).

## CALL FOR ENROLMENT 2026/2027 – GENERAL PROVISIONS

- If the grading scale stated on the certificate differs from the above conversion rules, that scale shall be taken into account. In cases where there are more than six passing grades or where grades are expressed as percentages and the grading scale is not stated on the certificate, each grade shall be converted using the following formula:  $Y - 2 = (5 - 2) / (a - b) \times (X - b)$ , where:
  - a = the highest passing grade in the grading scale;
  - b = the lowest passing grade in the grading scale;
  - X = the grade to be converted;
  - Y = the converted grade;
  - 2 = the lowest passing grade in the Slovenian grading scale;
  - 5 = the highest passing grade in the Slovenian grading scale.

### 3. Evaluation of Overall Achievement in the Final Two Years of Upper Secondary School [table of contents](#)

- For the purpose of determining achievement in the final two years of secondary school, the achievement recorded on the certificate for each individual year shall be taken into account.
- If overall achievement for a particular year is not stated, the average of the applicant's grades in that year shall be taken into account.
- In cases of deviations from the criteria for determining overall achievement, the overall achievement stated in a certificate issued by the secondary school and submitted by the applicant together with the annual final certificate shall be taken into account.
- If an annual certificate shows a failing grade in a particular subject for a given year, but it is evident from the certificate that the student may progress to the next year or is nevertheless permitted to take the final examination, the student shall be awarded a grade of 2 (sufficient) for that subject.
- If overall achievement in the final semester is not stated on the certificate and only permission to take the Matura or final examination is indicated, the final grades of the last semester shall be taken into account in determining the overall achievement for that year.

### 4. Evaluation of Achievement in Recognised Final Examinations Taken before 1 June 1995 [table of contents](#)

- Overall achievement in a recognised final examination taken before 1 June 1995 shall be determined in points by adding together the grades for individual subjects recorded on the final certificate.
- Where **two** subjects have been passed in the recognised final examination, the sum of the grades for the two subjects shall be taken into account. The maximum possible number of points is 10.
- Where **three** subjects have been passed in the recognised final examination, the sum of the grades for the three subjects shall be taken into account. The maximum possible number of points is 15.
- Where **four** subjects have been passed in the recognised final examination, the sum of the grades for the four subjects shall be taken into account. The maximum possible number of points is 20.
- Where **five** subjects have been passed in the recognised final examination, the sum of the grades for the five subjects shall be taken into account. The maximum possible number of points is 25.
- Where a **larger** number of subjects (more than five) has been passed in the recognised final examination, the sum of the five highest-graded subjects shall be taken into account as overall achievement. The maximum possible number of points is 25.
- If no grades are stated on the applicant's final certificate (e.g. in the case of a diploma), the same provisions shall apply as for generations of students in vocationally oriented education in Slovenia who were not required to take a final examination. Overall achievement in the final examination shall be determined by adding together the overall achievement in the penultimate and final years of secondary school, expressed in points. The maximum possible number of points is 10.
- If the final certificate expresses final achievement only in percentages (%) or solely as an average value (grade), this shall be taken into account.

## CALL FOR ENROLMENT 2026/2027 – GENERAL PROVISIONS

- If an applicant's final secondary school certificate does not state grades for individual subjects, the grade from the final year of secondary school shall be taken into account for a specifically required subject in the final examination, where this is determined by the selection criteria for a particular study programme. If the applicant did not take the required subject in the **final year**, they shall receive zero (0) points for that subject. An applicant may also take an examination in an individual subject in Slovenia in accordance with the provisions of the General Matura Act or abroad. In such cases, appropriate proof of having passed the examination must be submitted. If, in accordance with the selection criteria for a particular study programme, the applicant did not take the specifically required subject in any year of schooling, they shall receive zero (0) points for that subject.
- No additional points shall be awarded for subjects taken at a higher level of difficulty in a recognised final examination.
- If the applicant did not take a subject with exactly the same title as used in Slovenia, but took a similar subject (or several such subjects), the grade(s) from that/those subject(s) shall be taken into account. A subject with a different title may also be taken into account if the secondary school issues a certificate confirming that it includes the content of the required subject.
- Where, in accordance with the selection criteria, achievement in a specific subject in the final year of secondary school is to be scored, and several suitable subjects appear on the certificate, the highest grade shall be taken into account.
- Where a **negative grade for a particular subject is recorded on the final certificate**, but it is evident from the certificate that the student passed the final examination, the applicant shall receive zero (0) points for that subject. In this case, the total number of points shall be calculated by adding together the grades for all subjects recorded on the final certificate (including the negative grade, counted as zero (0) points). The applicant's total number of points shall be compared with the maximum possible number of points.

### 5. Assessment of achievement in a Recognised Vocational Matura

[table of contents](#)

- For determining overall achievement in the vocational matura, the same provisions apply as for students who completed the vocational matura in Slovenia (Rules on the Vocational Matura, Official Gazette of the RS No. 99/01 et seq.).
- In the case of restricted enrolment, overall achievement in the vocational matura is determined as follows: in the selection procedure for admission to **higher professional study programmes**, four subjects are taken into account for overall achievement in the vocational matura: two subjects from the compulsory part of the vocational matura (mother tongue and a professional-theoretical subject) and two subjects from the elective part of the vocational matura (a foreign language or mathematics, and a fourth subject). The maximum possible number of points is 23.
- In the case of restricted enrolment, overall achievement in the vocational matura is determined as follows: in the selection procedure for admission to **university study programmes**, five subjects are taken into account for overall achievement in the vocational matura: two subjects from the compulsory part of the vocational matura (mother tongue and a professional-theoretical subject), two subjects from the elective part of the vocational matura (a foreign language or mathematics, and a fourth subject), and the grade in a general matura subject. The specified general matura subject must be taken by the candidate in Slovenia in accordance with the provisions of the General Matura Act or abroad. In both cases, the candidate must submit appropriate proof of having passed the general matura subject examination. The maximum possible number of points is 31.

The general matura subject examination must not be in a subject that the candidate has already taken in the vocational matura, except for exceptions published in the annual call for enrolment.

If there are a larger number of subjects (five or more) in a recognised vocational matura, the overall achievement in the vocational matura is determined as follows: for admission to professional higher education programmes, four subjects are taken into account: two subjects from the compulsory part of the vocational matura (mother tongue and a professional-theoretical subject) and the two best-graded subjects from the elective part of the vocational matura (a foreign language or mathematics and a fourth subject). For admission to university study programmes, five subjects are taken into account: two subjects from the compulsory part of the vocational matura (mother tongue and a professional-theoretical subject), the two

best-graded subjects from the elective part of the vocational matura (a foreign language or mathematics and a fourth subject), and the grade in a general matura subject. The specified general matura subject must be taken by the candidate in Slovenia in accordance with the provisions of the General Matura Act or abroad. In both cases, the candidate must submit appropriate proof of having passed the general matura subject examination.

- If a candidate has taken several vocational matura subjects that correspond to the required subject, the best-graded subject is taken into account.
- The grade in the mother tongue is scored on a scale from 2 to 8 (higher level). If the candidate's final certificate does not include grades for the **general education subjects of the vocational matura** (mother tongue and foreign language and mathematics), the grade in the respective subject from the final year of secondary school is taken into account when determining the **overall result of the vocational matura**. If the applicant did not take the required subject in the final year, they shall receive zero (0) points for that subject. An applicant may also take an examination in an individual subject in Slovenia in accordance with the provisions of the General Matura Act or abroad. In such cases, appropriate proof of having passed the examination must be submitted. If the candidate's final certificate does not include a grade for the **vocational-theoretical subject and the fourth subject of the vocational matura**, the candidate receives zero (0) points. An applicant may also take an examination in an individual subject in Slovenia in accordance with the provisions of the General Matura Act or abroad. In such cases, appropriate proof of having passed the examination must be submitted.
- If the selection criteria for a specific study programme also include a grade **for a specially required general education subject of the vocational matura** (mother tongue, foreign language, or mathematics), the grade from the final year of secondary school shall be taken into account in accordance with the selection criteria if this grade is not stated on the candidate's final certificate. If the applicant did not take the required subject in the final year, they receive zero (0) points for that subject in the selection procedure. An applicant may also take an examination in an individual subject in Slovenia in accordance with the provisions of the General Matura Act or abroad. In such cases, appropriate proof of having passed the examination must be submitted.
- If the candidate's final certificate does not include a grade for the **specially required vocational-theoretical subject and the fourth subject of the vocational matura**, the candidate receives zero (0) points. An applicant may also take an examination in an individual subject in Slovenia in accordance with the provisions of the General Matura Act or abroad. In such cases, appropriate proof of having passed the examination must be submitted.
- If the applicant did not take a subject with exactly the same title as used in Slovenia, but took a similar subject (or several such subjects), the grade(s) from that/those subject(s) shall be taken into account.
- If a negative grade is recorded for an individual subject on the vocational matura certificate, but the certificate shows that the student has passed the vocational matura, the holder of the certificate shall receive zero points for that subject. The total number of points achieved is calculated by adding together the grades for all subjects listed on the final certificate (including the negative grade, which counts as zero points). The applicant's total number of points shall be compared with the maximum possible number of points.

### 6. Evaluation of Achievement in a Recognised General Matura

[table of contents](#)

- The same rules apply to determining overall achievement in the general matura as apply to students who have completed the general matura in Slovenia (Matura Examination Act, Official Gazette of the RS No. 29/08 et seq., and Rules on the General Matura, Official Gazette of the RS No. 29/08 et seq.).
- In the event of restricted enrolment, for a general matura consisting of five subjects that the applicant may take at different levels of difficulty, overall achievement is determined in the selection procedure on the basis of three compulsory subjects (mother tongue, foreign language, and mathematics) and two elective subjects of the general matura.
- If a grade for an individual **compulsory** subject of the general matura (mother tongue, foreign language, or mathematics) is not stated on the applicant's final certificate, the grade from the final year of secondary school in that subject shall be taken into account when determining **overall achievement**. If the applicant did not take the required subject in the final year, they shall receive zero (0) points for that subject. An

applicant may also take an examination in an individual subject in Slovenia in accordance with the provisions of the General Matura Act or abroad. In such cases, appropriate proof of having passed the examination must be submitted.

- If the candidate's final certificate does not state a grade for a **specifically required subject** of the **compulsory part** of the general matura (mother tongue, foreign language, and mathematics), as defined by the selection criteria for a particular study programme, the grade from that subject in the final year of secondary school shall be taken into account. If the applicant did not take the required subject **in** the final year, they shall receive zero (0) points for that subject. An applicant may also take an examination in an individual subject in Slovenia in accordance with the provisions of the General Matura Act or abroad. In such cases, appropriate proof of having passed the examination must be submitted.
- If the candidate's final certificate does not state a grade for a **specifically required elective subject** of the general matura, where such a subject is stipulated by the selection criteria of a particular study programme, the candidate shall receive zero (0) points for that subject. An applicant may also take an examination in an individual subject in Slovenia in accordance with the provisions of the General Matura Act or abroad. In such cases, appropriate proof of having passed the examination must be submitted. Where more than five subjects are included in a recognised general matura, the overall achievement attained in the general matura shall be calculated on the basis of three compulsory subjects (mother tongue, foreign language, and mathematics) and the two highest-graded elective subjects of the general matura.
- If the applicant has taken several subjects corresponding to the required subjects, the highest-graded subject shall be taken into account.
- If, in the country where the certificate was obtained, different levels of difficulty are not available, the scale applicable to the final examination taken in five or four subjects shall be used for calculating the total of converted grades. The maximum total number of points is 25 for five subjects and 20 for four subjects, provided that the applicant has completed three compulsory subjects of the general matura. If the final certificate does not state a grade for an individual compulsory subject of the general matura (mother tongue, foreign language, and mathematics), the grade from the final year of secondary school in that subject shall be taken into account when determining overall achievement. If the applicant did not take the required subject in the **final year**, they shall receive zero (0) points for that subject.
- For specifically required grades in the subjects of the compulsory part of the general matura (mother tongue, foreign language, and mathematics), in the case of restricted enrolment, additional points are added to the subject grades in accordance with the General Matura Regulations, even in the case of a single-level grading scale (subjects taken at the basic level).
- If it is evident from the certificate that the subject corresponding to a compulsory general matura subject (mother tongue, foreign language, and mathematics) was taken at a higher level of difficulty, additional points are added to the grade in accordance with the General Matura Regulations.
- A foreign language grade obtained abroad is assessed in the same way as if it had been obtained in a secondary school in Slovenia.
- If the applicant did not take a specific matura subject with exactly the same title as those used in Slovenia, but took a similar or related subject (or several such subjects or contents), the grade for that subject is taken into account. A subject with a different title may also be taken into account if the secondary school issues a certificate confirming that it includes the content of the required subject.
- Assessment of achievement in the general matura **with three compulsory subjects that applicants may take at the higher level**: in the total number of points, the three subjects of the compulsory part of the general matura are taken into account. For subjects taken at the higher level, additional points are added according to the rule: 2 + 1, 3 + 2, 4 + 2, 5 + 3. The overall grade is calculated using the formula: overall achievement = converted grade 1 + converted grade 2 + converted grade 3  $\times \sqrt{2}$  (1.41). The maximum number of points is 34.
- Assessment of achievement in the general matura with **three compulsory subjects that applicants may take only at one (basic) level**: in the total number of points, the three subjects of the compulsory part of the general matura are taken into account. The sum of the grades from the three subjects is taken into account. The maximum possible number of points is 15.

## CALL FOR ENROLMENT 2026/2027 – GENERAL PROVISIONS

- If a negative grade is recorded for an individual subject on the general matura certificate, but the certificate shows that the student has passed the general matura, the holder of the certificate shall receive zero points for that subject. The total number of points achieved is calculated by adding together the grades for all subjects listed on the final certificate (including the negative grade, which counts as zero points). The applicant's total number of points shall be compared with the maximum possible number of points.
- Where there are **more** than five subjects in a recognised general matura, the overall score is calculated as the sum of five subjects, namely three subjects from the common (compulsory) part of the general matura and two elective subjects. The maximum possible number of points is 34 (where subjects are taken at different levels, i.e. basic and higher level) or 25 (where subjects are taken only at the basic level).

### 7. Assessment of achievement in the European Baccalaureate

For applicants who completed upper secondary education under the European Schools programme, grades from the European Baccalaureate certificate or annual reports are converted into grades of the Slovenian upper secondary grading scale in accordance with the Rules on the Inclusion from the Educational Programme of the European Schools into the Slovenian Education System (Official Gazette of the Republic of Slovenia No. 25/17).

The European Baccalaureate certificate is, by law, equivalent to the general matura certificate in Slovenia and therefore no recognition procedure is required.

### 8. Evaluation of Achievement in International Baccalaureate table of contents

For the assessment of achievement in the International Baccalaureate, the provisions of the Rules on the Implementation of the International Baccalaureate Programme (Official Gazette of the Republic of Slovenia, No. 67/04, as amended) apply.

Under the law, the International Baccalaureate (IB) diploma is equivalent to the General Matura Certificate in Slovenia, and no recognition procedure is required.
