

In accordance with the constitutionally guaranteed autonomy of the University and on the basis of the Higher Education Act (Official Gazette of the Republic of Slovenia, No. 32/12 – officially consolidated text with amendments, supplements and corrections) in the Decision on the transformation of the University of Ljubljana (Official Gazette of the Republic of Slovenia, No. 28/00, with amendments, supplements and corrections), the Senate of the University of Ljubljana at its meeting on 26 September 2017 and the Steering Committee of the University of Ljubljana at its meeting on 28 September 2017 adopted the following:

Supplementation of the Statute of the University of Ljubljana

Article 1

In the Statute of the University of Ljubljana (Official Gazette of the Republic of Slovenia No. 4/2017), the second paragraph of Article 72 is amended to read: "If a Member of the University does not elect a dean in the elections, the dean is appointed by the Rector from among the higher education teachers from the UL, who meet the conditions from Article 69 of this Statute."

Article 2

In the first paragraph of Article 94, the text "by decision" is replaced with "by resolution".

Article 3

In the first paragraph of Article 106, the word "decision" is replaced with the word "resolution".

Article 4

The first paragraph of Article 107 shall be amended to read: "Unless otherwise stated in this Statute, the Student Council shall decide on the complaint of a student when it comes to an appeal against the decision of other bodies or working bodies of the Member of the University upon the first instance. The Commission of the University takes the decision on the first instance and is responsible for deciding on appeals by students."

Article 5

The first paragraph of Article 109 is amended to read: "The body's decision on the appeal is final and cannot be challenged by an objection or other regular legal remedies."

Article 6

In the second paragraph of Article 115, the word "resolutions" is replaced with the word "decisions".

Article 7

In the first paragraph of Article 120, the following sentence is added: "On-going examination and assessment of knowledge (colloquia, tests, assessment of laboratory exercises, etc.) may also be carried out by a University assistant."

Article 8

Article 135 shall be read as follows: "Procedures for the acquisition of a doctorate of science shall be specified in more detail in the University Regulations."

Article 9

In the last sentence of Article 191, the words "Members of the University" is deleted.

Article 10

In Article 199, a new second paragraph shall be added to read: "Notwithstanding the preceding paragraph of this Article, students enrolled in three-year doctoral study programmes may complete studies in these study programmes with a validity of the doctoral dissertation topic of four years, but not later than end of the academic year 2025/2026."

Article 11

In Article 202, a new second paragraph shall be added to read: "The provision of Article 128 shall not apply to those students who passed all their exams and to students who have passed all the exams and completed all other obligations of the study programme in the time prior to losing the status of the student, but who did not submit the final work, if not more than two years have passed since the loss of the student status, provided that they have handed in the final work by 1 October 2019."

Article 12

These amendments shall enter into force on the day following their publication in the Official Gazette of the Republic of Slovenia.
