

## DOCTORAL DISSERTATION PROPOSAL PRESENTATION

### **Doctoral seminar with the presentation of research work (methodology and partial results of the doctoral dissertation) in the 2nd year of study**

Doctoral seminars are organized individually for each doctoral student whose Doctoral Studies Committee has been named. The date of the seminar will be arranged with the seminar coordinator, doctoral student, mentor, co-mentor and Doctoral Studies Committee members. In the academic year 2022/2023, the seminar coordinator is prof. Andreja Kukec.

1. The doctoral student prepares the doctoral dissertation proposal in Word (and Power Point (max. 15 slides). The mentor and co-mentor sign the Word document, confirming that they agree with the content. The doctoral student sends both documents to [andreja.kukec@mf.uni-lj.si](mailto:andreja.kukec@mf.uni-lj.si), [anja.oven@uni-lj.si](mailto:anja.oven@uni-lj.si) and [ajda.bleiweis@uni-lj.si](mailto:ajda.bleiweis@uni-lj.si) at least **one week before the presentation**, otherwise the presentation cannot take place on the agreed date.

The doctoral dissertation title should sum up the content of the doctoral dissertation proposal and be as short as possible. It must not exceed the length of one sentence and comprise any semicolons, colons or dashes.

2. The doctoral dissertation proposal presentation may be up to 15 minutes long. The doctoral student presents the preliminary results of their research work, experience (positive and negative) and an estimation of the hypotheses.

The purpose of the doctoral seminar in the 2nd year, which is evaluated with 5 ECTS, is not to repeat the presentation of the doctoral dissertation drafts from the 1st year.

3. The doctoral student must substantiate the relevance of the proposed doctoral dissertation proposal, present the hypotheses, research methods and partial results. Finally, they must define the original contribution to science or to the development of the scientific field of environmental protection.

4. After the presentation, the Doctoral Studies Committee asks questions, followed by other professors and doctoral students that can also give opinions and comments. The presentation and questions are minuted and the student acquires 5 ECTS on the basis of the minutes.

5. Participation at doctoral seminars is obligatory for all doctoral students of the 2nd year. The date and location will be announced accordingly. An attendance list will be drawn up. Only excused absences will be considered. 6. The methodology and partial results of the doctoral dissertation must be presented in the presence of mentor or comentor. The presentation cannot take place without the mentor or comentor.

7. The instructiveness of the presentation and responsiveness of the public also contribute to the grade.

The successfully completed doctoral seminar with doctoral dissertation proposal presentation is one of the conditions for progression into the 3rd year of study.
