Mladi raziskovalec oz. mlada raziskovalka bo raziskovalno delo opravljal/opravljala na Oddelku za primerjalno in splošno jezikoslovje Filozofske fakultete Univerze v Ljubljani in v sklopu študij, ki potekajo v okviru programske skupine P6-0218 (Teoretične in aplikativne raziskave jezikov: kontrastivni, sinhroni in diahroni vidiki). Mladi raziskovalec oz. raziskovalka se bo usposabljal/usposabljala tudi na področju pedagoškega dela. Predvidena je namreč pomoč pri izvedbah vaj pri predmetih z ožjega ali širšega področja njegovega/njenega raziskovalnega dela v okviru študijskega programa Primerjalno jezikoslovje.

Njegovo/njeno raziskovalno delo bo usmerjeno v po metodologiji zgodovinsko- in primerjalnojezikoslovno raziskovanje sinhronih in diahronih danosti starih indoevropskih jezikov, s poudarkom na preučevanju informativnosti (povednih lastnosti) take indoevropske jezikovne veje ali vej, ki so v sodobni indoevropistici bistvene za korekcijo slike o danostih in zakonitostih indoevropskega prajezika ter njegovih razvojnih plasteh (kakršna izhaja iz primerjalnojezikoslovne sopostavitve centralnih oz. manj perifernih jezikovnih sistemov), v prvi vrsti torej anatolske veje (s poudarkom na hetitščini) in toharščine, in sicer predvsem z vidika oblikoslovja in besedotvorja (ter glasoslovja, zlasti v kolikor je to neobhodno za metodološko neoporečno ugotavljanje internoprimerjalnih dejstev in vzpostavljanje eksternoprimerjalnih povezav).

Od kandidata oz. kandidatke se pričakuje aktivno vpenjanje v domač in tuj raziskovalni prostor, kar bo izkazoval/izkazovala z udeležbo na konferencah ter pripravo (so)avtorskih znanstvenih člankov, zato je zaželeno, da kandidat oz. kandidatka že izkazuje raziskovalne izkušnje, ki jih lahko tudi izpriča z objavami in/ali aktivno udeležbo na konferencah, simpozijih ipd., in da je bilo njegovo/njeno dosedanje raziskovalno delo metodološko vezano na principe diahronega jezikoslovja in se je vsebinsko dotikalo problematike indoevropskega primerjalnega jezikoslovja.

Ker bo delo mladega raziskovalca oz. raziskovalke tesno zvezano s preučevanjem starih indoevropskih jezikov v interno- in eksternoprimerjalni luči, kar terja suverenost na področju tako sinhrono (opisne) kot diahrono (zgodovinske) slovnice več jezikovnih sistemov (stara indijščina, hetitščina, stara grščina, latinščina, gotščina ipd.), mora kandidat oz. kandidatka izkazovati ustrezno izobrazbo (prvostopenjski in drugostopenjski študij (indoevropskega) primerjalnega jezikoslovja).

The junior researcher will be trained at the Department of Comparative and General Linguistics at the Faculty of Arts, University of Ljubljana, and be intimately involved in the research interests of the

ongoing Faculty's domestic research programme P6-0218 (*Theoretical and Applied Linguistic Research: Contrastive, synchronic, and diachronic aspects*). In addition to scholarly activities, he or she will also undertake educational training, by taking on a few tutorials in the Comparative Linguistics programme such as directly connected to the candidate's research interests.

The research project shall be based on a historical and comparative linguistic inquiry into the synchronic and diachronic circumstances of the individual ancient languages of the Indo-European family, the main focus being on the instructive value of a branch or several branches that in contemporary Indo-European comparative linguistics have proved to play a pivotal role in the process of rectifying the descriptive facts about the Indo-European proto-language and its chronological layering (predicated on the combined data of the central and other, less peripheral linguistic systems), i.e., first and foremost the Anatolian branch (with Hittite as its most representative member) and Tocharian, and there primarily from the view-point of morphology and word formation (as well as phonology in as far as the latter must be unavoidably studied to enable a methodologically sanitary internal reconstruction and bring in a securely established set of data gained in the process of external comparison).

The candidate will be expected to engage with the academic community in the national and international scholarly setting by attending relevant conferences and through the preparation of scientific papers (joint and/or independent), so that it is desired that the candidate have some previous research experience, which he or she is able to demonstrate by scientific publications and/or active attendance at conferences, symposia etc., and that his or her previous research activities involve a methodology symptomatic of historical linguistics and is more or less directly focused on the issues in contemporary Indo-European comparative linguistics.

Given that in the course of the research project the junior researcher will be heavily involved in the internally and externally focused comparative study of the individual ancient Indo-European languages, which automatically requires specific competencies in the field of both descriptive (synchronic) as well as historical (diachronic) grammar of a number of ancient Indo-European languages (such as Sanskrit, Hittite, Old Greek, Latin, Gothic, etc.), the candidate must hold a relevant degree such as a BA and MA in (Indo-European) comparative linguistics.
